## WATER ACT 1989

I, Mark Anderson, Director, Water Industry Management, as delegate of the Minister for Conservation and Environment make the following Order:

## APPOINTMENT OF THE BRIGHT DISTRICT WATER BOARD ORDER 1991

1. This Order is called the Appointment of the Bright District Water Board Order 1991.

2. The Order is made under the powers conferred by Division 2 of Part 6 of the *Water Act 1989* and all other available powers.

3. This Order takes effect on 1 January 1992.

4. In this Order—

"Act" means the *Water Act 1989*;

"Authority" means the Bright District Water Board constituted by an Order in Council, dated 5 June 1991;

"Former Authority" means the King Valley Water Board constituted by an Order in Council dated 26 June 1984.

5. On and from the date on which this Order takes effect—

(a) The Authority takes over the whole of the property, rights, liabilities, obligations powers and functions under the Act of the former Authority including the management and control of the existing water districts named below:

(i) Moyhu Urban;

(ii) Moyhu Waterworks;

(iii) Oxley Urban District; and

(iv) Whitfield Waterworks.

6. The former Authority is abolished.

(a) This is an Order referred to in section 98 (2) (a) of the Act.

(b) Under section 100 (2) (a) of the Act, the affected Authorities have applied to me for the Order to be made.

(c) Under section 98 (2) (a) of the Act, I have agreed to the terms and conditions for the takeover made by this Order with the affected Authorities.
