ORDER UNDER SECTION 9 (2) RELATING

Act No. 45/1990

I. J. Davis McCaughey, Governor of Victoria, acting with the advice of the Executive Council and under section 2 of the *Vocational Education*

and Training Act 1990, make the following Proclamation:

1. The purpose of this Proclamation is to bring into operation certain provisions of the *Vocational Education and Training Act 1990*.

2. Part 3, Part 6 (other than sections 80 to 84), Part 7, sub-sections 95 (4) and (6), section 96, Division 2 of Part 9 (other than sub-paragraph 98 (3) (f) (ii)), sections 118 and 119 and the Schedule of the *Vocational Education and Training Act 1990* will come into operation on 1 January 1991;

3. Sections 80 to 84 of the *Vocational Education and Training Act 1990* will come into operation on 1 March 1991; and

4. Sections 46 to 71, sub-section 95 (2), section 97, Division 3 of Part 9, sections 108 to 117 and section 120 of the *Vocational Education and Training Act 1990* will come into operation on 1 July 1991.
