


MORTLAKE SPRING (MORTLAKE) GROUNDWATER SUPPLY CATCHMENT

The groundwater catchment to a spring and a bore controlled by the Mortlake Water Board located within a water reserve adjacent to CA 19 Township of Mortlake and within a road reserve adjacent to CA 29, Section 7, Parish of Mortlake respectively and as indicated on Plan No. S-1488, hereunder, to be known as the Mortlake Spring (Mortlake) Groundwater supply catchment area.



SERRA RANGE TRIBUTARIES (DUNKELD) WATER SUPPLY CATCHMENT



ST. ENOCH'S SPRING WATER SUPPLY CATCHMENT



- (c) To provide incentive to Licensed Plumbers and Drainers to perform and present for inspection, work which complies with the Sewerage and Water Supply Regulations.
- (d) To enable cost recovery at an individual service level, thereby eliminating the cross subsidisation from all ratepayers.
- (e) To rationalise the administration of plumbing inspections.

The Regulatory Impact Statement therefore concludes that the proposed changes are the means of achieving these objectives.

The City of Berwick has prepared Amendment No. L38 to the Local Section of the Berwick Planning Scheme.

The amendment comprises three sections and proposes to amend the following:

Section A—Berwick Business-Berwick Village Zone

This component of the amendment involves the creation of a Berwick Business-Berwick Village zone which is proposed to replace the existing Restricted Business Zone within the Commercial area.

The areas proposed to be included in this new zone include:

- All properties abutting High Street, between Lyall Road and Wheeler Street on the north side, and between Clyde Road and Gloucester Avenue on the south side.
- The existing shops along the western side of Gloucester Avenue.
- The existing shops along the eastern side of Clyde Road, between High Street and the public car park.
- Blackburne Square and Loveridge Walk.

 Currently all these properties are in a Restrict.

Currently all these properties are in a Restricted Business zone.

The major features of the Berwick Business-Berwick Village zone include:

- * Specific purpose statements and guidelines for permit which reflect the goals, objectives and recommended actions of the Berwick Village Commercial Centre Strategy Plan.
- * The emphasis on retailing as the predominant ground floor land use, with offices on any upper levels.
- * A maximum building height restriction of two storeys above ground level.
- * All advertising signage (except a direction sign and home occupation sign) to be subject to a permit, with specific guidelines for permit to reflect the purpose statements of the zone.
- The prohibition of a number of specific signs, which are considered completely inappropriate within the Berwick Village. These include a panel sign, promotion sign, high wall sign, above-verandah sign, or any form of bunting, reflective or animated sign.

Section B-Berwick Office Zone

It is proposed to modify some of the provisions in the existing Berwick Office Zone. These modifications include:

- Making a dual occupancy and a flat discretionary uses (presently they are both as of right).
- * Deleting two discretionary uses listed in section 2 (thereby making them prohibited uses), which are not considered appropriate in this fringe office area around the Berwick Village. These uses are: Commercial Display Area and Commercial Vehicle Park.
- * Introducing additional guidelines for considering applications to include reference to the adopted Berwick Village Commercial Centre Strategy Plan, considering the impact of developments on the visual amenity and streetscapes, and to ensure adequate on site parking and loading facilities are provided.

Section C-Amendment to the Zoning Maps

A total of fifteen (15) site specific rezonings/ reservations are proposed, resulting from the recommendations in the Strategy Plan.

- 1. A small parcel of land which forms part of Berwick Primary School, abutting Peel Street, is proposed to be rezoned from a Berwick Residential—Berwick Township Zone to a Primary School Reservation.
- 2. It is proposed to introduce a new zone into the Planning Scheme (Berwick Business-Berwick Village Zone) to replace the existing Restricted Business Zone that covers most of the retailing area in High Street, Berwick. (The exception to this is the land in a Restricted Business Zone on the south side of High Street, east of Gloucester Avenue).
- 3. It is proposed to change the existing Berwick Residential—Berwick Township Zone on the south west corner of Peel Street and Wheeler Street, to a Public Purposes 19 (Local Government) reservation. This land, where the Girl Guide Hall is currently situated, is owned by the City of Berwick.
- 4. It is proposed that the following properties be rezoned from a Berwick Residential—Berwick Township Zone to a Berwick Office Zone:

All properties abutting the east side of Wheeler Street, between Peel Street and High Street.

Disposal of Waste and the Use of Municipal Tips

1. Purpose .

The purpose of this Part is to-

- (a) maintain the municipal district at all times in a clean and sanitary condition;
- (b) regulate the usage and depositing of rubbish at the municipal tips; and
- (c) prevent and remedy all nuisances or conditions liable to be dangerous to health or offensive to people.

2. Collection of Refuse and Rubbish

- 2.1 The occupier of any premises must use a rubbish bin in which all refuse and rubbish produced or accumulated on the premises must be kept.
- 2.2 The bins used should be constructed of galvanised iron, steel or strong and impervious moulded plastic material or other strong impervious material to the satisfaction of the environmental health officer. The bins must not be capable of absorption of any offensive matter or any escape by leakage. In addition all bins
 - (a) be capable of being easily moved by one person;
 - (b) have adequate carry handles or wheels properly attached;
 - (c) have a lid, which seals to make the bin water tight, fly and vermin proof and must be fitted at all times.

3. Use of Municipal Tips

- 3.1 The municipal tips as designated by Council will be available for use by residents and ratepayers of the municipal district for the disposal of waste generated from within the municipal district, subject to the fees, charges, terms and conditions as determined by Council from time to time.
- 3.2 The designated municipal tips are located on the Sunraysia Highway (opposite cemetery), Corack Road (adjacent to the aerodrome), Watchupga (Reserve adjacent to Crown Allotment 17, Parish of Watchupga), Curyo (Reserve adjacent to Crown Allotment 2B, Curyo).

4. Depositing of Waste at Municipal Tips

4.1 The Council will only permit the dumping of building materials (excluding cardboard, plastic or paper packaging), garden refuse, fencing materials, oil tanks, car bodies, hardware, fridges or other household hardware at the Corack Road Tip Area.

6.2 Any person found scavenging at the tips will be guilty of an offence against section 5 (1) of the Local Law.

Initial Penalty: First Offence \$50.00. Subsequent Penalty \$150.00.

7. Infringement Notices

- 7.1 The Shire Secretary, Shire Engineer, Environmental Health Officer, or in their absence, an authorised officer may serve a local law infringement notice in the prescribed form on a person to whom the officer believes has committed an infringement referred to in section 6 requiring the person to pay the penalty for that infringement within 28 days of the issue of the infringement notice.
- 7.2 If the infringement notice is not withdrawn and the person pays to the Council the amount referred to in the infringement notice within the period of 28 days or such further period as the Council or the authorised person may allow, no conviction will be recorded against that person for the alleged infringement.
- 7.3 If a person issued with an infringement notice makes a written representation to the Shire Secretary or Shire Engineer within 28 days of the infringement notice, the infringement notice must be bought to the attention of the Council.
- 7.4 The Council may consider any written representations and any other relevant information and must consider any such material brought to their attention at the Council meeting immediately proceeding the receipt of the information.
- 7.5 Subject to clause (7.9) the decision of the Council on any representations shall be final.
- 7.6 The Council may at any time withdraw an infringement notice as a result of consideration of any representations made.

- 7.7 Where an infringement notice is withdrawn, the person upon whom it was served is entitled to a refund of any payment which that person has made on the infringement notice.
- 7.8 In the event of the failure of a person served with an infringement notice to pay the amount specified within 28 days of the issue of the notice or such further time as the Council or authorised officer may permit, the Council or the authorised officer may pursue the matter by prosecuting for an offence or taking any steps which may be available for enforcing the penalties.
- 7.9 Any person served with a local law infringement notice is entitled to disregard the notice and defend the prosecution in Court.


