Requires persons to give their name and address and/or produce any permit when required by an authorised officer.

Allows Council to grant exemptions to any person and waive, reduce or refund any fee.

Requires Council to provide a register of permits.

Allows, as an alternative to prosecution, an authorised officer to issue infringement notices.

Sets penalties at-

10 penalty units for an initial offence 20 penalty units for a subsequent offence 1 penalty unit for each day after conviction or

during which an offence continues. (N.B. A penalty unit value is \$100).

#### LOCAL LAW No. 6

Environmental Health (Refuse Disposal) Regulation of Household Refuse

Regulates the deposit of refuse and rubbish in public places and the practice of placing household refuse out for collection which is not in an approved refuse receptacle.

Requires occupiers of a dwelling to keep and maintain approved refuse receptacles for the purpose of depositing household refuse.

Specifies the construction of a conventional refuse container.

Requires the owner of flats or units to provide an area to place rubbish receptacles.

Requires the occupier of a dwelling to place his/her rubbish receptacle on the nature strip abutting the premise for collection and to remove the container within 24 hours of it being collected.

Sets the number of receptacles allowed to be placed out for collection at 4 conventional or one mobile receptacle.

Specifies what is not allowed to be placed in a receptacle for collection (prohibited wastes).

Regulation of Other Refuse and Waste

Allows Council to provide a collection of articles/refuse outside that normally placed out for collection.

Regulates the placement of waste containers (e.g. skips) by providing the issue of permits.

Provides for the matters Council shall have regard to when considering an application for a permit.

Prescribes the form of the permit and allows Council to grant, conditionally grant, refuse, correct or revoke a permit.

Sets the period of currency of a permit at twelve months.

#### Trade Waste Containers

Sets the requirement for construction and maintenance of Trade Waste containers and requires such containers to be emptied at regular intervals of no more than seven days.

Sets the requirements for the area in which such a container is stored.

#### General Provisions

Requires Council to keep a register of all permits issued.

Allows, as an alternative to prosecution, an authorised officer to issue an infringement notice.

Set penalties at-

10 penalty units for an initial offence.

20 penalty units for a subsequent offence.

1 penalty unit for each day after a conviction for which an offence continues.

#### LOCAL LAW No. 7 Streets and Roads

#### Merchandise on Pavements

Regulates by permit, the practice of exhibiting, placing out for exhibition any merchandise adjacent or near a premises.

Prescribes the method of application for such permits and allows Council to grant, conditionally grant or refuse such application. The Council may also set a permit fee.

#### Exhibition of Advertising Signs

Regulates by permit, the practice of exhibiting, placing out for exhibition any advertising sign adjacent or near a premises.

Prescribes the method of application for such permits and allows Council to grant, conditionally grant or refuse such application. The Council may also set a permit fee.

#### Exhibition of Signs by Estate Agents and Impounding Signs Generally

Prescribes the method of application for such permits and allows Council to grant, conditionally grant or refuse such application. The Council may also set a permit fee.

Schedule 6 of this law sets out the conditions with which such permits are granted. Such conditions include—

that Council is informed of the location of such signs.

each sign is not more than 1200 mm in height and 750 mm in width.

maximum of three signs for auction and the signs are to be removed 30 minutes after completion of such auction.

no sign advertising a premises inspection shall be exhibited unless the permit holder or agent is at the premises.

Allows authorised officers to impound signs contravening this law and, if not returned to the owner the sign/s may be sold, destroyed or given

#### Furniture on Pavements

Regulates by permit, the practice of providing for public use, on the pavement any seats, umbrellas, tables, chairs or other furniture.

Prescribes the method of application for such permits and allows Council to grant, conditionally grant or refuse such application. The Council may also set a permit fee.

#### Vehicular Advertising

Regulates by permit, the practice of leaving a vehicle standing on any road, road reservation or land vested in Council a motor vehicle which has attached to it any advertising.

Prescribes the method of application for such permits and allows Council to grant, conditionally grant or refuse such application. The Council may also set a permit fee.

#### Protruding Materials

Regulates by permit, the practice of attaching advertising, banners, bunting etc., to any verandah or awning.

Prescribes the method of application for such permits and allows Council to grant, conditionally grant or refuse such application. The Council may also set a permit fee.

#### Shopping Trolleys

Prohibits persons leaving shopping trolleys in public places and allows authorised officers to impound such trolleys.

Allows a notice to be served on the owner of impounded trolleys. Trolleys will be surrendered if the prescribed fee is paid.

If a trolley is not claimed it can be sold, destroyed or given away by Council.

Stationery Vehicles on Roads

Prohibits persons dismantling, painting or repairing vehicles on roads.

Skatehoards

Prohibits the use of skateboards on pavements.

Dog Litter

Requires the person in control of a dog to remove any litter deposited by that dog in a public place.

Street Furniture

Prohibits a person from destroying, removing, defacing or damaging any street furniture.

Identification of Premises

Requires the owner/occupier of premises to clearly number a premises.

Overhanging Branches

Prohibits the owner/occupier of premises to allow a tree or plant to—

overhang the pavement at a height less than three metres

obstruct the vision of motorists

be unsafe for the users of the road or pavement.

Allows authorised officers to serve notice on the owners/occupiers of such properties to remove the offending tree/plant.

Obstructions

Prohibits a person from causing an obstruction on a road or pavement and allows an authorised officer to remove the obstruction and retrieve costs from the offender.

Vehicle Crossings

Regulates by permit the construction and maintenance of vehicle crossings both permanent and temporary.

Prescribes the method of application for such permits and allows Council to grant, conditionally grant or refuse such application. The Council may also set a permit fee.

General Provisions

Allows Council to exempt any person or thing from the operation of Division 2-16 of this Local Law.

Allows Council to direct application for permits to be advertised and to consider written submissions from persons affected by the permit.

Empowers Council to revoke and/or correct permits, to keep a register of permits, issue infringement notices and provide for offences and penalties.


