BULLA PLANNING SCHEME  
Notice of Approval of Amendment  
Amendment L61

The Minister for Planning has approved Amendment L61 to the Bulla Planning Scheme.

The amendment comes into operation on the date this notice is published in the *Government Gazette*.

The amendment includes the following changes:

1. The modification of Clause 104-6, 3 Site Specific Control—Environmental Audit in the Restricted Business Zone which affects CA 42, Section 17, Evans Street, Sunbury.
2. The rezoning of CA 44, Section 17, Brook Street, Sunbury from Railways reservation to Restricted Business Zone.
3. The rezoning of CA 39, Section 17, north west corner of Station Street and Evans Street, Sunbury from Railways reservation to Local Government reservation.
4. The rezoning of CA 51, Section 17, north west corner of Station Street and Evans Street, Sunbury from Railway reservation to Main Road reservation.

A copy of the amendment can be inspected, free of charge, during office hours at the offices of the Shire of Bulla, Macedon Street, Sunbury and at the Department of Planning and Development, 477 Collins Street, Melbourne.
