NOTICE OF VARIATION OF TERMS AND CONDITIONS OF A PIPELINE LICENCE

Whereas sub-section (1) of section 28A of the *Pipelines Act 1967* provides that the Minister may by notice published in the *Government Gazette*, amend, vary, add to, or revoke a term or condition stated or included in a licence or add a term or condition to the licence, I, Sidney James Plowman, Minister for Energy and Minerals, do now hereby vary the terms and conditions of a Pipeline Licence No. 12 in the manner indicated in the schedule hereto:

Schedule

1. Delete "39.12 Kilometres" from Clause I (A) (iii) of the schedule and substitute "30.40 Kilometres".
2. Delete "7235 kPa" from Clause I (D) of the schedule and substitute "9928 kPa".
3. Delete ", subject to its satisfactory clearance by a Risk Analysis which is acceptable to the Director, to operate at that pressure and which Analysis must be carried out within a period of six months from the date of this renewal.

Temporary approval is granted to continue to operate this pipeline at a pressure not to exceed 9928 kPa until the official commissioning of the Esso/BHP truck filling facility at Long Island Point, when the operating pressure in this pipeline, shall revert back to the normal operating pressure of 7235 kPa." from Clause I (D) of the schedule and
