Road Safety Act 1986 TEMPORARY EXTENSION OF METROPOLITAN TAXI ZONE

Section 143A (1) of the Transport Act 1983 enables the Governor in Council to proclaim an area or areas as a taxi-cab zone or zones.

The purpose of this Order is to temporarily extend the Metropolitan taxi zone boundary to include the Calder Park Thunderdome on 1 February 1993. The zone shall extend from Robertsons Road with the boundary following the Calder Freeway, Holden Road, the Sydenham railway line.

The Governor in Council under section 143A (1) of the Transport Act 1983 by this Order declares that for the purposes of the Act:

A temporary extension of the Metropolitan Taxi Zone will apply on 1 February 1993. The boundary shall be extended from Robertsons Road, Keilor along the Calder Freeway to Holden Road and the Sydenham railway line.
