FISHERIES (SCALLOP FISHING—PORT PHILLIP BAY FISHERY) (AMENDMENT) NOTICE No. 21/1993

1. *Title*

This notice may be cited as the Fisheries (Scallop Fishing—Port Phillip Bay Fishery) (Amendment) Notice No. 21/1993.

2. *Commencement*

This notice comes into operation on 1 September 1993.

3. *Objective*

The objective of this Notice is to amend the times when fishing is permitted for the taking of scallops from the waters of Port Phillip Bay.

4. *Authorising provision*

This Notice is made under section 80 of the *Fisheries Act 1968*.

5. *Amendment of fishing times*

In the Fisheries (Scallop Fishing—Port Phillip Bay Fishery) Notice No. 20/1993 for clause 6 (1) substitute—

“6 (1) Subject to section 15 (1) (h) of the Act the holder of a scallop licence endorsed—“valid for scallop fishing in all Victorian waters” or “valid for scallop fishing in the waters of Port Phillip Bay” must only dredge for or take scallops for sale from the waters of Port Phillip Bay—

(a) on any Monday; and

(b) during the hours between 5.00 a.m. and 5.00 p.m. on the days on which dredging for or taking scallops is permitted under paragraph (a).”
