Crown Land (Reserves) Act 1978
ORDER GIVING APPROVAL TO GRANT
LEASE

I, Mark Alexander Birrell, Minister for Conservation and Environment, under sections 17D and 17DA of the *Crown Land (Reserves) Act 1978*, being satisfied that—

- (i) there are special reasons which make granting of a lease reasonable and appropriate in the particular circumstances; and
- (ii) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under that Act—

by this Order approve the granting of a lease for yacht club purposes by the Committee of Management of part of the Protection of the Coastline Reserve—Port Fairy, to the Port Fairy Yacht Club Incorporated of the former Harbourmaster's residence and adjoining yard, being part of the land permanently reserved for protection of the coastline by Order in Council dated 16 March 1983 and published in the *Government Gazette* on 23 March 1983 (page 654).
