Fisheries Act 1968 FISHERIES NOTICE No. 26/1993

I, Charles Geoffrey Coleman, Minister for Natural Resources, after consultation with the Victorian Fishing Industry Federation make the following Fisheries Notice:

FISHERIES (SCALLOP FISHING—PORT PHILLIP BAY FISHERY) (TEMPORARY CLOSURE) NOTICE No. 26/1993

Title

1. This Notice may be cited as the Fisheries (Scallop Fishing—Port Phillip Bay Fishery) (Temporary Closure) Notice No. 26/1993.

Commencement

2. This Notice comes into operation on 24 September 1993.

Objective

3. The objective of this Notice is to prohibit the use of a dredge for the taking of scallops from the waters of Port Phillip Bay during the period commencing on 24 September 1993 and ending on 1 October 1993.

Authorising provision

4. This Notice is made under section 80 of the Fisheries Act 1968.

Revocation

5. The *Fisheries (Scallop Fishing—Port Phillip Bay Fishery) Notice No. 20/1993 is revoked.

Taking of scallops from Port Phillip Bay prohibited

6. A person must not use a dredge for the taking of scallops from the waters of Port Phillip Bay during the period commencing on 24 September 1993 and ending on 1 October 1993.

Penalty

- 7. Any person who contravenes this Notice is liable to a penalty of 20 penalty units.
