Vocational Education and Training Act 1990 ABOLITION OF THE COUNCIL OF THE RICHMOND COLLEGE OF TECHNICAL AND FURTHER EDUCATION

Purpose

1. The purpose of this Order is to abolish the Council of the Richmond College of Technical and Further Education and to assign its property, rights and obligations to the Council of the Moorabbin College of Technical and Further Education.

Authority

2. This Order is made under section 24 of the *Vocational Education and Training Act 1990* on the recommendation of the State Training Board of Victoria made in accordance with that section.

Meaning of Terms

6. In this Order, unless inconsistent with the context or subject matter:

“**Abolished Council**” means the Council of the Richmond College of Technical and Further Education established by the revoked Order.

“**Act**” means the Vocational Education and Training Act 1990.

“**Council of the Moorabbin College of Technical and Further Education**” means the Council of that name established by the Order in Council made on 23 December 1991 called the Constitution of the Moorabbin College of Technical and Further Education Council Order 1991.

“**Revoked Order**” means the Order in Council called the Constitution of the Richmond College of Technical and Further Education Council Order 1991 made on 23 December 1991.

**Constitution of the Moorabbin College OF
Technical and Further Education Council
(Amendment) Order 1993**

Purpose

1. The purposes of this Order are—

- (a) to change the composition of the Council of the Moorabbin College of Technical and Further Education; and
- (b) to make consequential amendments to the Council Constitution.

Authority for Order

2. This Order is made under the power conferred by section 24 of the Act and in accordance with a recommendation of the State Training Board of Victoria given in accordance with that Act.

Name of Order

3. This Order is called the Constitution of the Moorabbin College of Technical and Further Education (Amendment) Order 1993.

Meaning of Terms

4. In this Order, unless inconsistent with the context or subject matter:

"the Act" means the Vocational Education and Training Act 1990;

"Council" means the Council established by the Council Constitution; and

"Council Constitution" means the Order in Council called the Constitution of the Moorabbin College of Technical and Further Education Council Order 1991 made on 23 December 1991, notice of which was published in the Government Gazette on 8 January 1992.

Amendment of Council Constitution

5. The Council Constitution is amended as follows:

- (a) In clause 6 (1), for "seventeen" substitute "twenty".
- (b) In clause 6 (2) (a), for "four" substitute "five".
- (c) In clause 6 (2) (b), for "four" substitute "five".
- (d) In clause 6 (2) (c), for "four" substitute "five".

Transitional Provisions

6. (1) The additional three offices of Council member created by clause 5 of this Order are deemed, for the purposes of the Council Constitution, to be vacant offices until persons are appointed to those offices in accordance with the Act and the Council Constitution.

(2) This Order does not affect the tenure of office of any member of the Council at the date this Order takes effect.

Date of Effect

7. This Order takes effect on and from 1 January 1994.

Vocational Education and Training Act 1990 ABOLITION OF RICHMOND COLLEGE OF TECHNICAL AND FURTHER EDUCATION

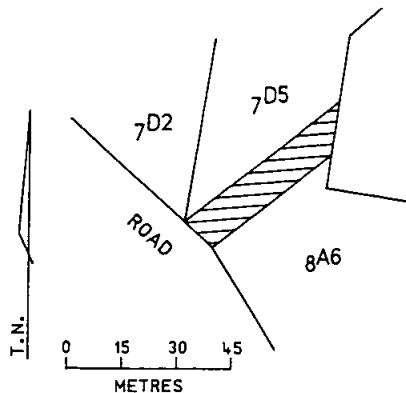

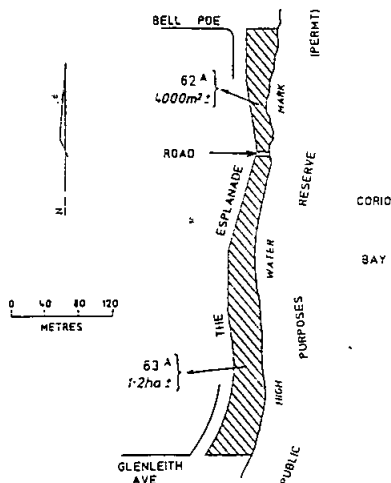
