CITY OF BROADMEADOWS (AMENDMENT) Local Law No. 9

Notice is hereby given that at the ordinary meeting of the Council of the City of Broadmeadows held on 14 December 1992, the Council resolved its intention to make a Local entitled "City of Broadmeadows (Amendment) Local Law No. 9" pursuant to the provisions of the Local Government Act 1989.





Planning and Environment Act 1987 ALBERTON PLANNING SCHEME Notice of Amendment to a Planning Scheme Amendment L29

The Shire of Alberton has prepared Amendment L29 to the Alberton Planning Scheme (Chapter 1 Coastal).

This amendment proposes to change the Planning Scheme by amending the Planning Scheme Ordinance (Local Section-Chapter 1) in the following ways:

- 1. To make "Relative Flats" the subject of a planning permit in the Agricultural Rural Residential Zone, Zone, Residential A Zone, Residential B Zone and the Reserved Residential Zone. The Scheme currently allows Relative Flats to be built without the need for a Town planning permit.
- 2. To incorporate the provisions of the Victorian Codes for Residential Development (subdivision and single dwellings) and (Multi-dwellings) into the Scheme, with some limitations with respect to overall development density, and matters in the Codes relating to prescribed amenity areas and daylight provision to residential developments.

These controls are to only apply to the sewered residentially zoned areas in Yarram, and require Council to have regard to a range of factors before granting a permit, including existing developments in the vicinity of a site.

The amendment does not propose to allow smaller lot sizes than are currently allowed by the Scheme, rather it is intended to allow developers to take advantage of modern design and siting principles.





Collection, Removal and Disposal of Refuse
Notice is hereby given that the Council of the
Shire of Mansfield proposes to make an
amendment to the present Local Law 3—
Collection, Removal and Disposal of Refuse.

The current Local Law provides for-

- (a) litter control, and in particular the promotion of a physical and social environment free of hazards to health;
- (b) collection and disposal of refuse, and in particular—
 - (i) the provision, use and control of receptacles for the deposit and collection of refuse and rubbish;
 - (ii) the prevention and regulation of the depositing of refuse upon the streets and other lands and places under the control of the Council;
 - (iii) the removal, replacement, cleansing and disinfection of receptacles for refuse and the use of deodorants or disinfectants in such receptacles; and
 - (iv) the collection of recyclable goods by approved or contracted persons;
- (c) prevention and abatement of nuisances;
- (d) prescription of penalties for breaches of this Local Law;
- (e) repeal of By-law No. 60;
- (f) generally for maintaining the good rule and government of the municipality.

The purport of the proposed amendment is-

- (a) to amend the definition of authorised officer, premises and receptacle;
- (b) to make minor changes to Clause 5, 11A, 16A, 17, 20 and 21;
- (c) to increase the penalties provided for in the Local Law;
- (d) to amend the schedule referred to in Clause 2 so as to—
 - (i) exempt an additional property from the collection route;
 - (ii) include additional properties on the collection route by substituting Mobile Garbage Bins Route Map 1992 for the previous map.

Streets and Roads Local Law

Notice is hereby given that the Council of the Shire of Mansfield at its meeting held on 15 December 1992, adopted Local Law 4—Streets and Roads Local Law in accordance with the provisions of the Local Government Act 1989.

The general purport of the Local Law is to achieve the objectives of providing for the control and management of traffic, use of roads by persons, vehicles and animals and to regulate the parking of vehicles for the safe and fair use by people, to provide for the peace, order and good government of the municipal district and to provide for the administration of Council's powers and functions.

In a way which is consistent with, and in furtherance of the above objectives, to prohibit, regulate and control activities and circumstances associated with—

- (i) obstructions to the free passage of vehicles and pedestrians; and
- (ii) the naming of roads and display of property numbers; and
- the provision of vehicle crossings including temporary vehicle crossings;
 and
- (iv) the prevention of stock wandering onto roads; and
- (v) the class of vehicle permitted to use a road so as to prevent damage to the road; and
- (vi) the circumstances under which stock may be driven on roads and generally prohibiting the grazing of stock on roads; and
- (vii) locations for the leaving of shopping trolleys; and
- (viii) the use of toy vehicles; and
- (ix) the riding of horses on road reservations within a built up area; and
- (x) the parking of long vehicles; and
- (xi) secondary activities on the road including—
 - (a) the placement of items on roads, footpaths and vehicles on roads;
 - (b) roadside trading;
 - (c) bulk rubbish containers on the

- (d) occupation of the road for works;
- (e) repair of vehicles and the deposit of substances on roads;
- (f) street parties, street festivals and processions;
- (g) collections on roads or adjacent to roads;
- (h) the management of parking and in particular disabled parking, illegal parking and time limit parking.

The Local Law prescribes penalties (including on the spot fines) for breaches of the Local Law.

The Local Law will be operative from the date of this notice.

Local Law 5 Environment Local Law

Notice is hereby given that the Council of the Shire of Mansfield at its meeting held on 15 December 1992, adopted Local Law 5—Environment Local Law in accordance with the provisions of the *Local Government Act* 1989.

The general purport of the Local Law is to achieve the objectives of providing a safe and healthy environment, to prohibit, regulate and control activities which may be dangerous, unsafe or detrimental to quality of life, to facilitate the provision of services in a way which enhances the environment and quality of life, to control nuisances and noise, odour and smoke emissions and other discharges to the enjoyment of life or health. safety and welfare of persons, to provide for the peace and order and good government of the municipal district and to provide for the administration of Council's powers and functions.

In a way which is consistent with, and in furtherance of the above objectives, to prohibit, regulate and control activities and circumstances associated with—

- (i) dangerous and unsightly land; and
- (ii) smoke emission, particularly emission from burning material and from chimneys and incinerators; and
- (iii) the use of recreational vehicles, particularly recreational vehicles which are not used on appropriate land or reserves or which emit excessive noise or air pollution; and

- (iv) swimming pools including the need to provide safety fences; and
- (v) the minimum requirements applying to an allotment and siting of a Class 1 Building thereon; and
- (vi) camping and temporary dwellings particularly in relation to identifying public and private land unsuitable for such uses: and
- (vii) circuses, carnivals, festivals and other similar events; and
- (viii) the selling of goods; and
- (ix) animals, including animal numbers and the keeping and control of animals; and
- (x) disposal of waste and recyclables including behaviour associated with waste disposal sites and septic tank systems; and
- (xi) interference with drains.

The Local Law prescribes penalties (including on the spot fines) for breaches of the Local Law.

The Local Law will be operative from the date of this notice.

A copy of the Local Law may be obtained from the Municipal Offices, 33 Highett Street, Mansfield during normal office hours.

Any person affected by the proposed Local Law amendments may make a submission relating to it to the Council. 



- 1. Report on the motorcycle accident situation in Victoria;
- 2. Investigate measures to improve the safety of motorcycling on Victorian roads, including the role of information campaigns and public education, and having particular regard to all road users:
- 3. Investigate ways of reducing the cost to the community of accidents involving motorcycles;
- 4. Report on the status and effectiveness of motorcycle training programs and licensing practices operating in Victoria including investigating the merit of schemes to encourage participation in rider training;

- 5. Investigate the relationship between the accident risk and engine capacity of motorcycles for Transport Accident Charge purposes;
- 6. Define a light motorcycle and report on any appropriate changes to existing driver licensing and registration requirements for the safe operation of such vehicles;
- 7. Investigate the potential of motorcycle conspicuity measures (including the mandatory operation of headlamps during daytime) to reduce the risk of accidents, to identify problems which might arise as a result of such measures, and in this regard to consider recent proposals to introduce an Australian Design Rule requiring daytime operation of headlamps;
- 8. Report on the efficiency and effectiveness of consultation between relevant Government road safety bodies and representative motorcycle rider and industry groups;
- Assess the benefits from the creation of an advisory body on motorcycle safety issues and to consider the composition and constitution of such a body.
