TRANSFER OF WORKS TO THE COLIBAN REGION WATER AUTHORITY ORDER 1994 No. 1

Citation

1. This Order is called the Transfer of Works to the Coliban Region Water Authority Order 1994 No. 1.

Appointment of Coliban Region Water Authority

5. On and from the date on which this Order takes effect all the works vested by or under the Local Government Act 1989 in the City of Greater Bendigo and managed under contract by the Shire of Bet Bet, that are associated with and necessary for the operation of the Laanecoorie Water Supply Systems are transferred to the Authority.

Pre-requisites for Making This Order

- (b) Under section 98 (4) (a) of the Act I have agreed the terms and conditions for the transfer made by this Order, with the Authority, the City of Greater Bendigo and the Shire of Bet Bet;

- (c) Under section 100 (2) (a) of the Act the affected Authority and bodies, the Coliban Region Water Authority, the City of Greater Bendigo and the Shire of Bet Bet have applied to me for the Order to be made;
- (d) Under section 100 (2) (b) of the Act I have consulted with the Minister administering the Local Government Act 1989 as Councils are affected; and
- (e) Under section 98 (4) (b) of the Act 1 am satisfied that appropriate provisions have been made in relation to the disposition of the works, the rights and liabilities of the City of Greater Bendigo and Shire of Bet Bet and the manner of repayment of any money borrowed in respect of the works.

Mallacoota Sewerage.

(b) The East Gippsland Region Water Authority takes over the staff of the Former Authority.

Abolition of Former Authority

6. The Former Authority is abolished as an Authority under the Act.

- (b) Under section 100 (1) (a) of the Act, I have advised the affected Authority, the Mallacoota Water Board in writing, of the reasons for my decision; and

Road Safety (Vehicles) Regulations 1988 EXTENSION OF PERIOD OF VALIDITY FOR GENERAL PERMITS FOR OVER DIMENSIONAL VEHICLES

Regulation 724 of the Road Safety (Vehicles) Regulations 1988 authorises the Roads Corporation, by notice in the Government Gazette, to allow vehicles and loads which exceed mass or dimenstion limits prescribed in the Regulations to be used on highways.
