## **Agricultural and Veterinary Chemicals Act 1992**

### **PROCLAMATION OF COMMENCEMENT**

### *Commencement*

2. This notice commences on 27 March 1994.

### *Objective*

3. The objective of this notice is to fix a close season for scallop fishing in Victorian waters other than Port Phillip Bay prohibiting the taking of scallops or the use of any scallop dredge.

### *Authorising Provision*

4. This notice is made under section 80 of the **Fisheries Act 1968**.

### *Revocation*

5. The \*Fisheries (Scallop Fishing—Ocean Fishery) Notice No. 3/1994 is revoked.

### *Taking of Scallops from Victorian waters (other than Port Phillip Bay)*

6. A person must not use a dredge for the taking of scallops from Victorian waters other than Port Phillip Bay during the period commencing on 27 March 1994 and ending on 26 June 1994.

### *Penalty*

7. Any person who contravenes this notice is liable to a penalty of 20 penalty units.
