1. that it is satisfied that no part of the land described in Certificate of Title Volume 10126, Folio 992 is required for public traffic;
2. that pursuant to item 3 (a) of Schedule 10 of the **Local Government Act 1989** (Vic.) such part of the land described in Certificate of Title Volume 10126, Folio 992 as constitutes a road be discontinued and that it is directed that notice of such discontinuance be published in the Government Gazette.
