Planning and Environment Act 1987 METROPOLITAN REGION PLANNING SCHEMES

Notice of Approval of Amendment Amendment R121

The Minister for Planning has approved Amendment R121 to the Regional Section of all planning schemes in the Metropolitan region.

The amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment extends the time of operation of the interim control concerning the effect of the height of a detached house on the residential amenity of adjoining land. The interim control is extended until 31 May 1995 pending the development of a replacement control.

A copy of the amendment can be inspected, free of charge, during office hours, at the Department of Planning and Development, Ground Floor, 477 Collins Street, Melbourne and at the offices of each Council in the Metropolitan region.

City of Melbourne Act 1993 ORDER TO AMEND

Whereas—

A. An Order was made on 24 November 1993, pursuant to section 25 of the **City of Melbourne Act 1993**, headed Order Specifying Services and Functions in the North Carlton Area which specified the services to be provided and functions to be performed by the Melbourne City Council in the area severed by that Act from the municipal district of the former Council of the City of Melbourne and included in the municipal district of the City of Fitzroy.

B. The City of Fitzroy has given notice pursuant to section 25 (3) of the Act that it

should provide and perform some of the services and functions specified in the above Order.

C. The City of Fitzroy and the Melbourne City Council were not able to reach agreement within the period allowed under section 25 (4) of the Act on the amount and manner of payments for the cost of the services provided and to be provided and the functions performed and to be performed by the City of Fitzroy.

Therefore I, Roger M. Hallam, Minister for Local Government, acting under section 25 (7) of the **City of Melbourne Act 1993**, amend the Order headed Order Specifying Services and Functions in the North Carlton Area and published in the Victoria Government Gazette No. S 86 dated 25 November 1993, by inserting the following—

1. Notwithstanding any other provisions of this Order the City of Fitzroy is responsible for the provision of the services and the performance of the functions specified in Schedule 1.
2. The Melbourne City Council must pay to the City of Fitzroy the sum of \$1 834 088 within 28 days for the cost of the services provided and to be provided and of the functions performed and to be performed by the City of Fitzroy.

SCHEDULE 1

- Collection of residential refuse
- Collection of residential recycling
- Collection of commercial refuse
- Collection of hard rubbish
- Street cleaning
- Clearance of litter bins in public places
- Removal of graffiti in public places
- Maintenance of street furniture
- Control of weeds in lanes, footways and channels
- Construction and maintenance of drains
- Reconstruction and maintenance of roads and footpaths, including reinstatements

- Street lighting
- Maintenance of median strips, tree islands, roundabouts, lawns and nature strips
