Swan Hill Pioneer Settlement Authority (Repeal) Act 1994 APPROVAL OF PLAN OF SURVEY

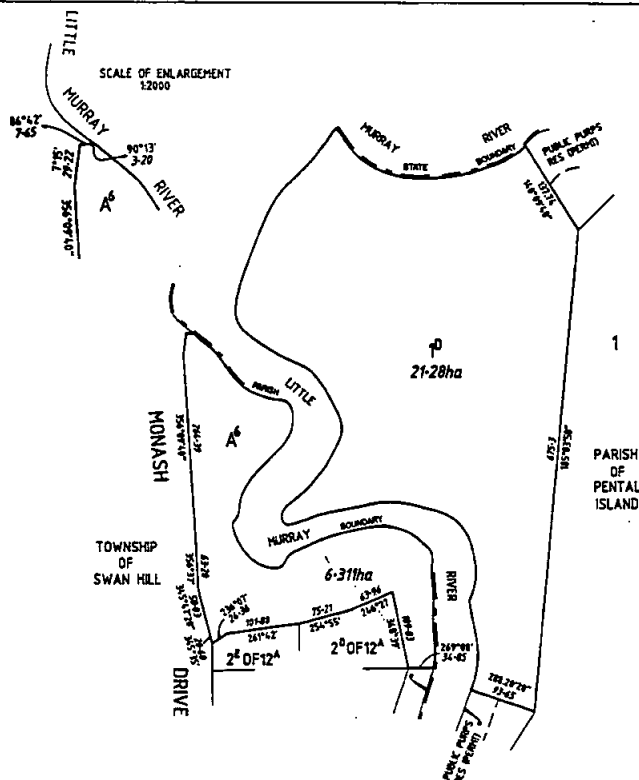

Act 1994**

**PROCLAMATION OF COMMENCEMENT
OF SPECIFIED PROVISIONS**
