**CREDIT ORDER NO. 83—SOUTH AUSTRALIAN ASSET MANAGEMENT CORPORATION**

The Governor in Council, under section 19 of the **Credit Act 1984** makes the following order:

*Citation*

1. This Order may be cited as "Credit Order No. 83—South Australian Asset Management Corporation".

*Commencement*

2. This Order shall take effect on and from 1 July 1994 or the date of publication in the Government Gazette (whichever occurs later).

*Exemption*

3. Parts III to VIII of the **Credit Act 1984** do not have effect in relation to the South Australian Assets Management Corporation to the extent that it enters into contracts for the

refinancing of or otherwise related to or arising out of an obligation between the State Bank of South Australia and a debtor which was entered into or incurred prior to 1 July 1994.

**CREDIT (ADMINISTRATION) ORDER—**

*Citation*

1. This Order may be cited as the "Credit (Administration) Order—South Australian Asset Management Corporation".

*Commencement*

2. This Order shall take effect on and from 1 July 1994 or the date of publication in the Government Gazette (whichever occurs later).

*Exemption*

3. Sections 37 (1) and 37 (2) of the **Credit (Administration) Act 1984** do not have effect in relation to the South Australian Asset Management Corporation to the extent that it enters into contracts for the refinancing of or otherwise related to or arising out of an obligation between the State Bank of South Australia and a debtor which was entered into or incurred prior to 1 July 1994.
