Notice of Amendment to a Planning Scheme
Amendment L31

The City of Ballarat has prepared an amendment to the Ballarat (Shire) Planning Scheme, Local Section, Chapter 1.

The amendment rezones land generally bounded by Victoria Street on the west, Nelson Street on the north, and Daveys Road (Cummins Street) on the south, in Miners Rest to an Extractive Industrial Zone.
