Water Act 1989

I, Charles Geoffrey Coleman, as Minister administering the Water Act 1989, make the following Order:

CONSTITUTION OF THE OUTER MARIBYRNONG AND WERRIBEE REGION WATER AUTHORITY ORDER 1994

Citation

1. This Order is called the Constitution of the Outer Maribyrnong and Werribee Region Water Authority Order 1994.

Enabling Powers

2. This Order is made under the powers conferred by Division 2 of Part 6 of the Water Act 1989 and all other available powers.

Date of Effect

3. This Order takes effect on the date on which it is published in the Government Gazette.

Definitions

4. In this Order:

"Act" means the Water Act 1989.

"Former Authority" means the Macedon Region Water Authority constituted by the Constitution of the Macedon Region Water Authority Order 1991 published in the Government Gazette No. S 57 of 20 November 1991.

Constitution of Outer Maribyrnong and Werribee Region Water Authority

5. On and from the date on which this Order takes effect:

- (a) there is constituted a new Authority; and
- (b) the corporate name of the new Authority is the Outer Maribyrnong and Werribee Region Water Authority.

Takeover of Former Authority

6. On and from the date on which this Order takes effect the new Authority constituted by Clause 5 of this Order takes over:

- (a) the whole of the property, rights, liabilities, obligations, powers and functions under the Act of the Former Authority including the management and control of the existing water districts named below:

Gisborne Urban;
Gisborne Waterworks;
Mount Macedon Urban;
Mount Macedon Waterworks;
Riddells Creek Urban;
Riddells Creek Waterworks;
Bulla-Diggers Rest Urban;
Bulla-Oaklands Junction Rural;
Sunbury Urban;
Sunbury Waterworks;
Woodend Urban; and
Woodend Waterworks;

and the management and control of the existing sewerage districts named below:

Gisborne Sewerage;
Riddells Creek Sewerage;
Diggers Rest Sewerage;
Sunbury Sewerage;
Woodend Sewerage; and

- (b) all the staff of the Former Authority.

Membership of the Outer Maribyrnong and Werribee Region Water Authority

7. (a) The membership of the new Authority constituted in Clause 5 of this Order is seven members appointed by the Minister in writing.

(b) In appointing persons as members, the Minister must ensure that the members, collectively, have qualifications relevant to, or experience in each of the following:

- (i) the business of the new Authority;
- (ii) public finance or economics;
- (iii) engineering;

- (iv) business management;
- (v) commerce;
- (vi) banking;
- (vii) environmental and water resource management;
- (viii) law.

Abolition of the Former Authority

8. The Former Authority is abolished.

Pre-requisites for Making this Order

9. (a) This is an Order referred to in section 98 (2) (a) of the Act;

(b) Under section 100 (2) (a) of the Act the affected Authority, the Macedon Region Water Authority, has applied to me for this Order to be made; and

(c) Under section 98 (2) (a) of the Act I have agreed to the terms and conditions for the takeover made by this Order with the affected Authority.

FISHERIES NOTICE No. 28/1994

Fisheries (Rock Lobster—Open Season)

Notice No. 28/1994

I, Charles Geoffrey Coleman, Minister for Natural Resources, after consultation with the Victorian Fishing Industry Federation, make the following Fisheries Notice:

Objective

1. The objective of this Notice is to allow holders of crayfish licences to set crayfish pots up to 12 hours prior to the commencement of the open season for rock lobster, to facilitate an orderly and safe start to the open season.

Authorising provision

2. This Notice is made under section 80 of the Fisheries Act 1968.

Commencement

3. This Notice commences on 14 November 1994.

Amendment of close season provisions

4. Despite anything to the contrary in regulation 9 (3) (b) of the *Fishing (Crayfish) Regulations 1989, a person operating a registered fishing boat licensed to take crayfish for sale, may leave or have any crayfish pot or crayfish coff immersed or set in any Victorian waters between the hours of 12.00 noon and 12.00 midnight on 15 November 1994.

Restriction on leaving wharf, jetty or pier

5. A person operating a registered fishing boat licensed to take crayfish for sale, must not leave the wharf, pier or jetty with any crayfish pot or crayfish coff on board the boat between the hours of 12.00 midnight on 14 November 1994 and 12.00 noon on 15 November 1994.

Penalty

6. Any person who contravenes any provision of this Notice is liable to a penalty of 20 penalty units.
