ORDER CONSTITUTING THE SHIRES OF
TOWONG, INDIGO, MILAWA, DELATITE,
STRATHBOGIE, MURRINDINDI,
MITCHELL, MOIRA AND CAMPASPE, THE
ALPINE SHIRE AND THE CITY OF
GREATER SHEPPARTON,
RE-CONSTITUTING THE RURAL CITY OF
WODONGA AND ALTERING THE
BOUNDARIES OF THE MUNICIPAL
DISTRICTS OF THE CITIES OF GREATER
BENDIGO AND WHITTLESEA AND THE
SHIRES OF OMEO, ELTHAM,
HEALESVILLE AND COHUNA

Whereas

A. On 3 June 1994 the Minister for Local Government, the Hon. Roger Murray Hallam, MLC (the Minister), required the Local Government Board to conduct a review under Part 10B of the **Local Government Act 1989** (the Act), on the most appropriate local government structure for the area comprising the municipal districts of the Shire of Alexandra, United Shire of Beechworth, City of Benalla, Shire of Benalla, Shire of Bright, Shire of Broadford, Shire of Chiltern, Shire of Cobram, Shire of Deakin, City of Echuca, Shire of Euroa, Shire of Goulburn, Town of Kyabram, Shire of Mansfield, Shire of McIvor, Shire of Myrtleford, Shire of Nathalia, Shire of Numurkah, Shire of Oxley, Shire of Pyalong, Shire of Rochester, Shire of Rodney, Shire of Rutherglen, Rural City of Seymour, City of Shepparton, Shire of Shepparton, Shire of Tallangatta, Shire of Tungamah, Shire of Violet Town, Shire of Waranga, City of Wangaratta, Shire of Wangaratta, Rural City of Wodonga, Shire of Upper Murray, Shire of Yackandandah, Shire of Yarrawonga and Shire of Yea (the review).

B. As required by section 220M of the Act, the Local Government Board has submitted a final report on the review to the Minister.

C. As required by sections 220M and 220P of the Act, the Minister has considered the

report and has recommended to the Governor in Council that an Order in Council be made in the following terms.

Now therefore, the Governor in Council acting under Part 10C of the Act orders that:

PART 1—PRELIMINARY

1. Definitions

In this Order—

“Act” means the **Local Government Act 1989**.

“adjacent area” means, in relation to a Council, an area which does not form part of the municipal district of the Council but which immediately before the commencement of this Order formed part of the municipal district of a former Council.

“appointed day” means the day on which this Order comes into operation.

“Commissioner” means a person appointed by the Governor in Council to administer a newly constituted Council.

“former Council” means in relation to—

- (a) the Towong Shire Council, the former Shires of Tallangatta and Upper Murray;
- (b) the Indigo Shire Council, the former Shires of Chiltern, Rutherglen and Yackandandah and the former United Shire of Beechworth;
- (c) the Wodonga Rural City Council, the former Rural City of Wodonga;
- (d) the Milawa Shire Council, the former Shires of Wangaratta and Oxley and the former City of Wangaratta;
- (e) the Alpine Shire Council, the former Shires of Bright and Myrtleford;
- (f) the Delatite Shire Council, the former Shires of Mansfield and Benalla and the former City of Benalla;
- (g) the Strathbogrie Shire Council, the former Shires of Euroa, Goulburn and Violet Town;
- (h) the Murrindindi Shire Council, the former Shires of Alexandra and Yea;

- (i) the Mitchell Shire Council, the former Shires of Broadford and Pyalong and the former Rural City of Seymour;
- (j) the Moira Shire Council, the former Shires of Cobram, Nathalia, Numurkah, Tungamah and Yarrawonga;
- (k) the Greater Shepparton City Council, the former Shires of Shepparton and Rodney and the former City of Shepparton;
- (l) the Campaspe Shire Council, the former Shires of Rochester, Deakin and Waranga, the former City of Echuca and the former Town of Kyabram;
- (m) the Greater Bendigo City Council, the former Shire of McIvor.

"neighbouring Council" means, in relation to another Council, a Council the municipal district of which an adjacent area in relation to that other Council forms part.

"newly constituted Council" means the Towong Shire Council, the Indigo Shire Council, the Wodonga Rural City Council, the Milawa Shire Council, the Alpine Shire Council, the Delatite Shire Council, the Strathbogie Shire Council, the Murrindindi Shire Council, the Mitchell Shire Council, the Moira Shire Council, the Greater Shepparton City Council and the Campaspe Shire Council constituted under clause 3 (1) of this Order.

2. Commencement

This Order comes into operation on the day it is published in the Government Gazette.

3. Constitution of New Councils

(1) On the appointed day there is constituted—

- (a) a body corporate constituted as a Shire Council by the name of the Towong Shire Council;
- (b) a body corporate constituted as a Shire Council by the name of the Indigo Shire Council;
- (c) a body corporate constituted as a Rural City Council by the name of the Wodonga Rural City Council;
- (d) a body corporate constituted as a Shire Council by the name of the Milawa Shire Council;
- (e) a body corporate constituted as a Shire Council by the name of the Alpine Shire Council;

- (f) a body corporate constituted as a Shire Council by the name of the Delatite Shire Council;
- (g) a body corporate constituted as a Shire Council by the name of the Strathbogie Shire Council;
- (h) a body corporate constituted as a Shire Council by the name of the Murrindindi Shire Council;
- (i) a body corporate constituted as a Shire Council by the name of the Mitchell Shire Council;
- (j) a body corporate constituted as a Shire Council by the name of the Moira Shire Council;
- (k) a body corporate constituted as a City Council by the name of the Greater Shepparton City Council; and
- (l) a body corporate constituted as a Shire Council by the name of the Campaspe Shire Council.

(2) On the appointed day the following councils cease to exist—

- (a) Shire of Alexandra;
- (b) United Shire of Beechworth;
- (c) City of Benalla;
- (d) Shire of Benalla;
- (e) Shire of Bright;
- (f) Shire of Broadford;
- (g) Shire of Chiltern;
- (h) Shire of Cobram;
- (i) Shire of Deakin;
- (j) City of Echuca;
- (k) Shire of Euroa;
- (l) Shire of Goulburn;
- (m) Town of Kyabram;
- (n) Shire of Mansfield;
- (o) Shire of McIvor;
- (p) Shire of Myrtleford;
- (q) Shire of Nathalia;
- (r) Shire of Numurkah;
- (s) Shire of Oxley;
- (t) Shire of Pyalong;
- (u) Shire of Rochester;
- (v) Shire of Rodney;
- (w) Shire of Rutherglen;
- (x) Rural City of Seymour;
- (y) City of Shepparton;
- (z) Shire of Shepparton;
- (za) Shire of Tallangatta;

- (ab) Shire of Tungamah;
- (ac) Shire of Violet Town;
- (ad) Shire of Waranga;
- (ae) City of Wangaratta;
- (af) Shire of Wangaratta;
- (ag) Rural City of Wodonga;
- (ah) Shire of Upper Murray;
- (ai) Shire of Yackandandah;
- (aj) Shire of Yarrawonga; and
- (ak) Shire of Yea.

(3) On the appointed day the persons holding office as Councillors of a Council referred to in clause 3 (2) cease to hold such office.

4. Commissioners

(1) The Chief Executive Officer of a newly constituted Council must call the first meeting of the Council to be held by the Commissioners which must be held within 3 days of the appointed day.

(2) Section 89 (4) of the Act does not apply to the first meeting of a newly constituted Council.

(3) The provisions of Schedule 1 apply to the Commissioners and meetings of the Commissioners.

PART 2—SHIRE OF TOWONG

5. Boundaries of the municipal district of the Towong Shire Council

On the appointed day the boundaries of the municipal district of the Towong Shire Council shall be fixed as described in Schedule 2.

6. Towong Shire Council is Successor in Law

From the appointed day—

- (a) all property, rights and assets of the former Councils are vested in the Towong Shire Council;
- (b) all liabilities of the former Councils are liabilities of the Towong Shire Council;
- (c) the Towong Shire Council is the successor in law of the former Councils.

PART 3—SHIRE OF INDIGO

7. Boundaries of the municipal district of the Indigo Shire Council

On the appointed day the boundaries of the municipal district of the Indigo Shire Council shall be fixed as described in Schedule 3.

8. Indigo Shire Council is Successor in Law

From the appointed day—

- (a) all property, rights and assets of the former Councils are vested in the Indigo Shire Council;
- (b) all liabilities of the former Councils are liabilities of the Indigo Shire Council;
- (c) the Indigo Shire Council is the successor in law of the former Councils.

PART 4—RURAL CITY OF WODONGA

9. Boundaries of the municipal district of the Wodonga Rural City Council

On the appointed day the boundaries of the municipal district of the Wodonga Rural City Council shall be fixed as described in Schedule 4.

10. Wodonga Rural City Council is Successor in Law

From the appointed day—

- (a) all property, rights and assets of the former Council are vested in the Wodonga Rural City Council;
- (b) all liabilities of the former Council are liabilities of the Wodonga Rural City Council;
- (c) the Wodonga Rural City Council is the successor in law of the former Council.

PART 5—SHIRE OF MILAWA

11. Boundaries of the municipal district of the Milawa Shire Council

On the appointed day the boundaries of the municipal district of the Milawa Shire Council shall be fixed as described in Schedule 5.

12. Milawa Shire Council is Successor in Law

From the appointed day—

- (a) all property, rights and assets of the former Councils are vested in the Milawa Shire Council;
- (b) all liabilities of the former Councils are liabilities of the Milawa Shire Council;
- (c) the Milawa Shire Council is the successor in law of the former Councils.

PART 6—ALPINE SHIRE

13. Boundaries of the municipal district of the Alpine Shire Council

On the appointed day the boundaries of the municipal district of the Alpine Shire Council shall be fixed as described in Schedule 6.

14. Alpine Shire Council is Successor in Law

On the appointed day—

- (a) all property, rights and assets of the former Councils are vested in the Alpine Shire Council;
- (b) all liabilities of the former Councils are liabilities of the Alpine Shire Council;
- (c) the Alpine Shire Council is the successor in law of the former Councils.

PART 7—SHIRE OF DELATITE

15. Boundaries of the municipal district of the Delatite Shire Council

On the appointed day the boundaries of the municipal district of the Delatite Shire Council shall be fixed as described in Schedule 7.

16. Delatite Shire Council is Successor in Law

On the appointed day—

- (a) all property, rights and assets of the former Councils are vested in the Delatite Shire Council;
- (b) all liabilities of the former Councils are liabilities of the Delatite Shire Council;
- (c) the Delatite Shire Council is the successor in law of the former Councils.

PART 8—SHIRE OF STRATHBOGIE

17. Boundaries of the municipal district of the Strathbogie Shire Council

On the appointed day the boundaries of the municipal district of the Strathbogie Shire Council shall be fixed as described in Schedule 8.

18. Strathbogie Shire Council is Successor in Law

On the appointed day—

- (a) all property, rights and assets of the former Councils are vested in the Strathbogie Shire Council;
- (b) all liabilities of the former Councils are liabilities of the Strathbogie Shire Council;
- (c) the Strathbogie Shire Council is the successor in law of the former Councils.

PART 9—SHIRE OF MURRINDINDI

19. Boundaries of the municipal district of the Murrindindi Shire Council

On the appointed day the boundaries of the municipal district of the Murrindindi Shire Council shall be fixed as described in Schedule 9.

20. Murrindindi Shire Council is Successor in Law

On the appointed day—

- (a) all property, rights and assets of the former Councils are vested in the Murrindindi Shire Council;
- (b) all liabilities of the former Councils are liabilities of the Murrindindi Shire Council;
- (c) the Murrindindi Shire Council is the successor in law of the former Councils.

PART 10—SHIRE OF MITCHELL

21. Boundaries of the municipal district of the Mitchell Shire Council

On the appointed day the boundaries of the municipal district of the Mitchell Shire Council shall be fixed as described in Schedule 10.

22. Mitchell Shire Council is Successor in Law

On the appointed day—

- (a) all property, rights and assets of the former Councils are vested in the Mitchell Shire Council;
- (b) all liabilities of the former Councils are liabilities of the Mitchell Shire Council;
- (c) the Mitchell Shire Council is the successor in law of the former Councils.

PART 11—SHIRE OF MOIRA

23. Boundaries of the municipal district of the Moira Shire Council

On the appointed day the boundaries of the municipal district of the Moira Shire Council shall be fixed as described in Schedule 11.

24. Moira Shire Council is Successor in Law

On the appointed day—

- (a) all property, rights and assets of the former Councils are vested in the Moira Shire Council;
- (b) all liabilities of the former Councils are liabilities of the Moira Shire Council;
- (c) the Moira Shire Council is the successor in law of the former Councils.

PART 12—CITY OF GREATER
SHEPPARTON

25. Boundaries of the municipal district of the
Greater Shepparton City Council

On the appointed day the boundaries of the
municipal district of the Greater Shepparton
City Council shall be fixed as described in
Schedule 12.

26. Greater Shepparton City Council is
Successor in Law

On the appointed day—

- (a) all property, rights and assets of the
former Councils are vested in the
Greater Shepparton City Council;
- (b) all liabilities of the former Councils are
liabilities of the Greater Shepparton
City Council;
- (c) the Greater Shepparton City Council is
the successor in law of the former
Councils.

PART 13—SHIRE OF CAMPASPE

27. Boundaries of the municipal district of the
Campaspe Shire Council

On the appointed day the boundaries of the
municipal district of the Campaspe Shire
Council shall be fixed as described in Schedule
13.

28. Campaspe Shire Council is Successor in
Law

On the appointed day—

- (a) all property, rights and assets of the
former Councils are vested in the
Campaspe Shire Council;
- (b) all liabilities of the former Councils are
liabilities of the Campaspe Shire
Council;
- (c) the Campaspe Shire Council is the
successor in law of the former
Councils.

PART 14—CITY OF GREATER BENDIGO

29. Changes to the boundaries of the municipal
district of the Greater Bendigo City Council

On the appointed day the boundaries of the
municipal district of the Greater Bendigo City
Council shall be fixed as described in Schedule
14.

30. Greater Bendigo City Council is Successor
in Law

On the appointed day—

- (a) all property, rights and assets of the
former Council are vested in the
Greater Bendigo City Council;
- (b) all liabilities of the former Council are
liabilities of the Greater Bendigo City
Council;
- (c) the Greater Bendigo City Council is
the successor in law of the former
Council.

31. Transitional Provisions

(1) Clauses 45, 46, 47, 48, 49, 52, 54, 55, 56,
58 and 60 of this Order apply to the Greater
Bendigo City Council as if the Greater Bendigo
City Council was a newly constituted Council.

(2) Unless amended or revoked by an Order
in Council or by the Greater Bendigo City
Council the local laws in force in the municipal
district of the former Council immediately
before the appointed day continue to apply in
the relevant part of its municipal district for the
period commencing on the appointed day and
ending on 7 April 1995 as if the local laws were
made by the Greater Bendigo City Council.

(3) The Greater Bendigo City Council shall
be responsible for the enforcement of local laws
within its municipal district and for continuing
any proceedings for the enforcement of those
local laws.

32. Savings Provision

Notwithstanding any reconstitution of the
Greater Bendigo City Council effected by this
Part, the Greater Bendigo City Council is
deemed to be the same body on and after as
before the appointed day and no act, matter or
thing is in any way abated or affected by reason
of any such reconstitution and any such act,
matter or thing may be continued and concluded
in all respects as if this Order had not been
made.

PART 15—SHIRE OF COHUNA

33. Changes to the boundaries of the municipal
district of the Shire of Cohuna

On the appointed day that part of the
municipal district of the former Shire of
Rochester which is not included in the
municipal district of the Campaspe Shire
Council shall be annexed to and form part of the

municipal district of the Shire of Cohuna and the boundaries of the municipal district of the Shire of Cohuna shall be altered accordingly.

34. Transitional and Savings Provisions

(1) Clause 56 of this Order applies to the Cohuna Shire Council as if the Cohuna Shire Council was a newly constituted Council.

(2) Unless amended or revoked by an Order in Council or by the Cohuna Shire Council the local laws in force in the municipal district of the former Shire of Rochester immediately before the appointed day continue to apply in the relevant part of its municipal district as if the local laws were made by the Cohuna Shire Council.

(3) The Cohuna Shire Council shall be responsible for the enforcement of local laws within its municipal district and for continuing any proceedings for the enforcement of those local laws.

(4) Notwithstanding any reconstitution of the Shire of Cohuna effected by this Part, the Cohuna Shire Council is deemed to be the same body on and after as before the appointed day and no act, matter or thing is in any way abated or affected by reason of any such reconstitution and any such act, matter or thing may be continued and concluded in all respects as if this Order had not been made.

PART 16—THE SHIRES OF ELTHAM AND HEALESVILLE AND THE CITY OF WHITTLESEA

35. Definition

In this Part "adjacent area" means in respect of the Shire of the Eltham, the Shire of Healesville or the City of Whittlesea, an area severed from the municipal district of the Shire of the Eltham, the Shire of Healesville or the City of Whittlesea, as the case may be, and included in the municipal district of the Murrindindi Shire Council by virtue of this Order.

36. Changes to the boundaries of the municipal districts of the Shires of Eltham and Healesville, and the City of Whittlesea

On the appointed day the boundaries of the municipal district of the Shire of Eltham, the Shire of Healesville and the City of Whittlesea shall be altered accordingly as a consequence of the boundaries fixed by Schedule 9 for the municipal district of the Murrindindi Shire Council.

37. Adjacent Areas—Transitional Provisions

(1) For the period commencing on the appointed day and ending ninety days from the appointed day, unless otherwise agreed between the Shire of Healesville and the Murrindindi Shire Council, the Shire of Healesville must provide the same services and perform the same functions in the adjacent area and in the same manner as if the area was in its municipal district and for that purpose any powers, duties and functions imposed or conferred by any Act on the Murrindindi Shire Council are deemed to be imposed by that Act on the Shire of Healesville.

(2) The Shire of Healesville must be reimbursed by the Murrindindi Shire Council the cost of providing services and performing functions in the adjacent area.

(3) The Shire of Healesville, the Shire of Eltham and the City of Whittlesea must each come to an agreement with the Murrindindi Shire Council on the apportionment, settlement, transfer, adjustment or determination of any property, income, assets, liabilities, expenses, staff or other matters in relation to an adjacent area within ninety days of the appointed day.

38. Savings Provision

Notwithstanding any reconstitution of the Shire of Eltham, the Shire of Healesville and the City of Whittlesea effected by this Part, the Eltham Shire Council, the Healesville Shire Council and the Whittlesea City Council are each deemed to be the same body on and after as before the appointed day and no act, matter or thing is in any way abated or affected by reason of any such reconstitution and any such act, matter or thing may be continued and concluded in all respects as if this Order had not been made.

PART 17—THE SHIRE OF OMEO

39. Definition

In this Part the "adjacent area" means the Dinner Plain area, being the area severed from the municipal district of the Shire of Omeo and included in the municipal district of the Alpine Shire Council by virtue of this Order.

40. Changes to the boundaries of the municipal district of the Shire of Omeo

On the appointed day the boundaries of the municipal district of the Shire of Omeo shall be altered accordingly as a consequence of the boundaries fixed by Schedule 6 for the municipal district of the Alpine Shire Council.

41. Transitional Provisions

(1) For the period commencing on the appointed day and ending ninety days from the appointed day, unless otherwise agreed between the Shire of Omeo and the Alpine Shire Council, the Shire of Omeo must provide the same services and perform the same functions in the adjacent area and in the same manner as if the area was in its municipal district and for that purpose any powers, duties and functions imposed or conferred by any Act on the Alpine Shire Council are deemed to be imposed by that Act on the Shire of Omeo.

(2) The Shire of Omeo must be reimbursed by the Alpine Shire Council the cost of providing services and performing functions in the adjacent area.

(3) The Shire of Omeo and the Alpine Shire Council must come to an agreement on the apportionment, settlement, transfer, adjustment or determination of any property, income, assets, liabilities, expenses, staff or other matters in relation to the adjacent area within ninety days of the appointed day.

42. Savings Provision

Notwithstanding any reconstitution of the Shire of Omeo effected by this Part, the Shire of Omeo is deemed to be the same body on and after as before the appointed day and no act, matter or thing is in any way abated or affected by reason of any such reconstitution and any such act, matter or thing may be continued and concluded in all respects as if this Order had not been made.

PART 18—GENERAL

43. Holding of the First Elections

(1) The date for the first election of Councillors for a newly constituted Council is to be fixed by the Minister by a notice published in the Government Gazette.

(2) For the purposes of holding the first election of Councillors, a newly constituted Council is deemed to have decided under section 35 of the Act to hold triennial elections and sub-sections (2) and (3) of that section do not apply in respect of that decision.

(3) Except as provided by this clause, the provisions of Part 3 of the Act apply to and in respect of the first and subsequent elections.

44. First Meeting of the Councillors of a Newly Constituted Council

(1) After the first election of Councillors for a newly constituted Council has been held, the Chief Executive Officer of the Council must call the first meeting of the Council which must be held within 10 days of the day on which the returning officer declares the result of the first election.

(2) At 9 a.m. on the day on which the first meeting of the Council is held under sub-clause (1)—

- (a) the Commissioners go out of office; and
- (b) the Councillors elected at the first election of the Council assume office as Councillors of the Council.

45. Staff

On the appointed day all the members of staff of a former Council become members of staff of the newly constituted Council with the same terms and conditions as those with the former Council and with the benefit of all accrued rights.

46. Delegations—Transitional Provisions

(1) With effect from the appointed day until revoked by the newly constituted Council all delegations made by a former Council or by the Chief Executive Officer of a former Council under the Act or any other Act remain in force.

(2) A newly constituted Council may, with the agreement of a neighbouring Council, delegate under section 98 of the Act a power, duty or function to a member of staff of that Council in respect of the period commencing on the appointed day and ending ninety days from the appointed day.

47. Rates—General Transitional Provisions 1994—1995

(1) Any rate or charge levied by a former Council under section 158 (3) of the Act for the 1994—1995 financial year is deemed to have been levied by the newly constituted Council.

(2) Any state deficit levy imposed by a former Council under the State Deficit Levy Act 1992 for the 1994—1995 financial year is deemed to have been imposed by the newly constituted Council.

48. Rates—Transitional Provisions for the Declaration and Levying of Rates 1994—1995

(1) If immediately before the appointed day a former Council had not declared a general rate

in respect of the 1994-1995 financial year, the newly constituted Council may, in accordance with the budget prepared by the former Council and having regard to any submissions made by a person in accordance with the Act, declare and levy any general rates, service rates and charges or municipal charge in respect of rateable land in the municipal district of the former Council.

(2) If immediately before the appointed day a former Council had declared but not levied any general rate in respect of the 1994-1995 financial year, the newly constituted Council may levy such rates and charges as have been declared by the former Council in respect of rateable land within the municipal district of the former Council.

(3) Notwithstanding clauses 48 (1) and 48 (2), a newly constituted Council can authorise a neighbouring Council to levy in respect of rateable land in an adjacent area such rates and charges as have been declared by the former Council or by the newly constituted Council, as the case may be.

49. Minimum Rates—Transitional Provisions 1995-1996

In the 1995-1996 financial year a newly constituted Council may levy a minimum rate in accordance with sub-section 3 (2) of the *Local Government (Consequential Provisions) Act 1989*.

50. Differential Rates—Transitional Provisions 1995-1996 & 1996-1997

In the 1995-1996 and 1996-1997 financial years a newly constituted Council may—

- (a) raise any general rate by the application of a differential rate pursuant to section 161 of the Act regardless of the system of valuation it is using;
- (b) apply a differential rate for a type or class of land according to its geographic location;
- (c) declare a different service rate or different annual service charge pursuant to section 162 of the Act in different areas.

51. Valuations—Transitional Provision

(1) Where different systems of valuation apply within the municipal district of a newly constituted Council, the newly constituted Council must determine to use a system of

valuation which applies to the whole of its municipal district for the purpose of declaring a rate in respect of the 1995-1996 financial year.

(2) If a newly constituted Council determines to change the system of valuation for the purpose of declaring a rate in respect of the 1995-1996 financial year, section 157 of the Act does not apply to that determination.

52. Adjacent Areas—Transitional Provisions

(1) For the period commencing on the appointed day and ending ninety days from the appointed day, unless otherwise agreed between the relevant Councils, a newly constituted Council must provide the same services and perform the same functions in an adjacent area and in the same manner as if the area was in its municipal district and for that purpose any powers, duties and functions imposed or conferred by any Act on a neighbouring Council are deemed to be imposed by that Act on the newly constituted Council.

(2) A newly constituted Council must be reimbursed by a neighbouring Council the cost of providing services and performing functions in the adjacent area.

(3) A newly constituted Council must come to an agreement with a neighbouring Council on the apportionment, settlement, transfer, adjustment or determination of any property, income, assets, liabilities, expenses, staff or other matters in relation to an adjacent area within ninety days of the appointed day.

53. Local Laws—Transitional Provisions

(1) On the appointed day any local law, or part of any local law, which deals with the meeting procedures or the common seal of a council, which has ceased to exist by virtue of clause 3 (2), is revoked.

(2) Sections 5 (3) and 91 (1) of the Act do not apply in respect of the common seal and meetings of a newly constituted Council while the newly constituted Council is under the administration of Commissioners.

(3) Unless amended or revoked by an Order in Council or by a newly constituted Council the local laws in force in the municipal district of the newly constituted Council immediately before the appointed day continue to apply in the relevant part of its municipal district for a period of 12 months from the appointed day as if the local laws were made by the newly constituted Council.

(4) A newly constituted Council shall be responsible for the enforcement of local laws within its municipal district and for continuing any proceedings for the enforcement of those local laws.

**54. Enforcement and Proceedings—
Transitional Provisions**

(1) With effect from the appointed day until revoked by a newly constituted Council all authorisations made by a former Council under section 224 of the Act remain in force.

(2) Where, immediately before the appointed day, proceedings to which a former Council was a party were pending or existing in any court or tribunal, then, except as otherwise provided in this Order, a newly constituted Council, as the case may be, is substituted for the former Council as a party to the proceedings and has the same rights in the proceedings as the former Council had.

55. References—Transitional Provisions

From the appointed day, any reference in any instrument or any other document of any kind to a former Council is, except as otherwise provided in this Order, to be construed as a reference to a newly constituted Council, as the case may be, unless the contrary intention appears.

56. Planning Matters—Transitional Provisions

(1) Except where a planning scheme specifies the Minister administering the **Planning and Environment Act 1987** or any other person to be the responsible authority, a newly constituted Council is the responsible authority for the purposes of the **Planning and Environment Act 1987** in relation to the planning schemes in force in its municipal district.

(2) Any reference in a planning scheme in force in the municipal district of a newly constituted Council to another council as a responsible authority for a particular purpose, is to be taken as a reference to the newly constituted Council in relation to the relevant part of its municipal district.

(3) For the purposes of the **Planning and Environment Act 1987** and the administration, amendment or enforcement of each of the planning schemes referred to in sub-clause (1)—

- (a) anything of a continuing nature (including a contract, agreement or

proceeding) done, commenced or made by or in relation to a council which ceases to exist by virtue of this Order may be done, enforced or completed by the newly constituted Council of the municipal district to which the matter relates;

- (b) anything done by or in relation to a council which ceases to exist by virtue of this Order that concerns a matter of a continuing nature has effect as if done by the newly constituted Council of the municipal district to which the matter relates.

57. Corporate Plan—Transitional Provisions

For the purpose of section 153A of the Act a newly constituted Council must prepare a corporate plan for the three year period commencing 1 October 1994 by a date set by the Minister.

58. Modified Reporting Requirements for the 1993–1994 Financial Year

(1) A newly constituted Council must prepare a report in respect of each former Council for the period commencing 1 October 1993 and ending on the day before the appointed day containing -

- (a) a report of the operations of the former Council during that period; and
- (b) audited financial statements for the former Council for that period.

(2) The provisions of the Act and the Local Government Regulations 1990 relating to the preparation and submission of annual reports, the preparation of reports of operations and the preparation, signing and audit of financial statements apply to a report prepared under sub-clause (1) with such modifications as are necessary, unless otherwise provided in this clause.

(3) For the purposes of section 128 (1) of the Act, the financial statements of a former Council must be signed by two Commissioners of the newly constituted Council and a person designated by the Council as having relevant financial management responsibilities for that purpose and regulation 85 of the Local Government Regulations 1990 is modified accordingly.

(4) Section 128 (2) of the Act does not apply to a report prepared under sub-clause (1).

(5) Except as provided in this clause, the requirements of section 126 of the Act do not apply to the newly constituted Council in respect of the 1993-1994 financial year.

59. Modified Reporting Requirements for the 1994-1995 Financial Year

A newly constituted Council must prepare an annual report for the 1994-1995 financial year in respect of the period commencing on the appointed day and ending on 30 June 1995 and the provisions of the Act and the Local Government Regulations 1990 relating to the preparation of annual reports are modified accordingly.

60. Registrar of Titles

The Registrar of Titles, on being requested to do so and on delivery of any relevant certificates of title or instrument, must make any amendments in the Register that are necessary because of the operation of this Order.

SCHEDULE 1 COMMISSIONERS

1. A Commissioner is entitled to receive—

- (a) an annual remuneration;
- (b) any travelling or subsistence allowances; and
- (c) any other allowances in relation to expenses incurred in the discharge of his or her duties—

that the Minister may from time to time determine in respect of the Commissioner.

2. Such remuneration, allowances and expenses are to be paid by the newly constituted Councils.

3. A Commissioner must—

- (a) ensure that the operations of a newly constituted Council are carried out in the most efficient and economic manner possible;
- (b) report to the Minister on such matters and at such intervals as the Minister may specify.

4. A Commissioner must exercise his or her powers and perform his or her functions subject to any written directions given by the Minister.

5. A Commissioner—

- (a) must not, without the consent of the Minister, while in office directly or indirectly engage in any paid employment outside the duties of his or her office;

- (b) may resign the office in writing signed by him or her and delivered to the Governor in Council;
- (c) may at any time be removed from office by the Governor in Council.

6. If a Commissioner—

- (a) becomes bankrupt or his or her property becomes in any manner subject to control under the law relating to bankruptcy;
- (b) is convicted of an indictable offence or of an offence which, if committed in Victoria, would be an indictable offence;
- (c) becomes incapable of performing the duties of office;
- (d) is removed from office or resigns the office; or
- (e) dies—

the office of a Commissioner becomes vacant.

7. During the absence from office or illness of a Commissioner, a person nominated by the Minister shall act in the place of the Commissioner and while so acting shall have, exercise and discharge all the responsibilities, liabilities, rights, powers, authorities, duties and functions conferred or imposed on the Commissioner by or under this Order.

8. An act or decision of a Commissioner is not invalid by reason only of a defect or irregularity in or in connection with the appointment of a Commissioner or that Commissioner, as the case may be.

9. No person shall be concerned to inquire whether any occasion had arisen requiring or authorising a person to act in the place of a Commissioner and all acts or things done or omitted to be done by the person, while so acting, shall be as valid and effectual and shall have the same consequence as if the acts or things had been done or omitted to be done by the Commissioner.

10. Where provision is made in any Act, regulation, rule, by-law, local law, instrument or document

- (a) for the Mayor, a councillor or the Chairperson or a member of a committee of the newly constituted Council or a former Council, to be a member of or to be represented on a board, council, committee, commission or other body, or to be a trustee, or to

be a member or director of a company, that provision has effect during the period of administration as if it provided for a Commissioner or some other person appointed by a Commissioner to be that member, representative, trustee or director;

- (b) for a Council to appoint a councillor to be the representative of the Council that provision has effect during the period of administration as if it provided for a Commissioner or some other person nominated by a Commissioner to be the representative; or
- (c) for a member of a board, council, committee, commission or other body to be appointed from a panel of councillors of municipal councils, that provision has effect during the period of administration as if it provided for a Commissioner or some other person nominated by a Commissioner to be included in the panel.

11. Sections 71, 74 and 75 of the Act do not apply to a Commissioner.

12. A quorum for a meeting of Commissioners is two Commissioners.

13. Except as provided in this Order, the procedure for meetings of newly constituted Councils may be determined by the Commissioners.

Gibbo; thence south-easterly by a direct line towards Forest Hill to the Murray River being a point on the state boundary, and thence generally northerly and westerly by the state boundary to the point of commencement.

ORDER APPOINTING THE
COMMISSIONERS AND CHIEF
EXECUTIVE OFFICERS OF THE SHIRES
OF TOWONG, INDIGO, MILAWA,

THE RE-CONSTITUTED RURAL CITY OF
WODONGA**

Whereas twelve new Councils have been constituted by Orders in Council under Part 10C of the **Local Government Act 1989** (the Act) the Minister has recommended to the Governor in Council that an Order be made, pursuant to section 220Q(o) of the Act, in the following terms.

Now therefore, the Governor in Council acting under Part 10C of the Act orders that:

1. Definitions

In this Order—

“former council” means the Shire of Alexandra, United Shire of Beechworth, City of Benalla, Shire of Benalla, Shire of Bright, Shire of Broadford, Shire of Chiltern, Shire of Cobram, Shire of Deakin, City of Echuca, Shire of Euroa, Shire of Goulburn, Town of Kyabram, Shire of Mansfield, Shire of McIvor, Shire of Myrtleford, Shire of Nathalia, Shire of Numurkah, Shire of Oxley, Shire of Pyalong, Shire of Rochester, Shire of Rodney, Shire of Rutherglen, Rural City of Seymour, City of Shepparton, Shire of Shepparton, Shire of Tallangatta, Shire of Tungamah, Shire of Violet Town, Shire of Wangaratta, City of Wangaratta, Shire of Wangaratta, Rural City of Wodonga, Shire of Upper Murray, Shire of Yackandandah, Shire of Yarrawonga and Shire of Yea.

2. Commencement

This Order comes into operation on the day it is published in the Government Gazette.

3. Commissioners

(1) The persons specified in column 1 of the Schedule are appointed to administer the Council specified in column 2 of the Schedule from the day this Order comes into operation until 9:00 a.m. on the day on which the first meeting of the Council specified in column 2 is held following the first election of councillors for the Council.

(2) The person specified in column 3 of the Schedule is appointed the Chairperson of the Commissioners.

4. Chief Executive Officers

(1) The person specified in column 4 of the Schedule is the person authorised to exercise

the powers and perform the duties and functions conferred or imposed on Chief Executive Officers by any other Order, the Act and any other Act until revoked by the Council specified in column 2 of the Schedule.

(2) Any authorisation given by a former Council under s.5 of the **Local Government (Miscellaneous Amendments) Act 1993** has no effect.
