## National Tennis Centre Act 1985 PROCLAMATION DIVESTING AND RESERVING RAILWAY LAND

Having received a recommendation from the Honourable the Minister for Conservation and Environment, I, Richard E. McGarvie, Governor of Victoria, acting with the advice of the Executive Council by this Proclamation:

- (a) under section 25A (2) of the National Tennis Centre Act 1985 ("the Act") revoke Folio of the Register, Volume 3929 Folio 762, Volume 3740 Folio 927 and Volume 2788 Folio 466 in so far as they relate to the land shown diagonally hatched on Plan of Survey Sheet 1 of 2 LEGL/94-43 lodged in the Central Plan Office ("the Plan");
- (b) under section 25A (5) of the Act divest the land shown cross hatched on the Plan from the Public Transport Corporation; and
- (c) under section 25A (9) of the Act provide that the land shown horizontally hatched on the Plan reverts to the Crown.
