





The purpose of this By-Law is to:

- (a) Regulate the discharge of trade waste to sewers.
- (b) Prescribe terms and conditions to be included in Trade Waste Agreements; and
- (c) Prescribe the method of charging for the receipt of trade waste.

- (c) 10 February 1995—the date for the purposes of section 22 (2) which is the date on or before which the Chief Executive Officer must make a voters' list.
- 3. For the purposes of any poll which may be conducted as provided for under Part 10B of the Act, the Chief Executive Officers and the Electoral Commissioner prepare voters' lists in relation to the Councils set out in Schedules 1 and 2 on the basis of the dates fixed for municipal council elections in the Order made on 8 March 1994 entitled "Municipal Council Elections 1994—Fixing of Dates" and printed in the Government Gazette on 10 March 1994 and the Chief Executive Officers must also certify the voters' rolls by 8 July 1994.
- 4. On the day this Order comes into operation—
