2. 1 November 1994 be specified as the date for the purposes section 65 (2) of the Act and in particular as the date on which—

- (a) the incorporation of Terang and District (Norah Cosgrave) Community Hospital and the Mortlake District Hospital shall be cancelled; and
- (b) a new registered funded agency entitled Terang and Mortlake Health Service shall come into existence as if incorporated under the Health Services Act 1988; and
- (c) the initial Board of Management of the new Terang and Mortlake Health Service will be constituted of the following members with terms of appointment commencing 1 November 1994 and for the period of office as specified:

The Governor in Council under section 19 of the Credit Act 1984 makes the following order:

*Citation*

1. This Order may be cited as Credit Order No. 85 Qantas Staff Credit Union Limited—Loan Contracts.

*Commencement*

2. This Order shall take effect on and from the date of publication in the Government Gazette.

*Application*

3. This Order has effect in relation to a loan contract under which the credit provider is Qantas Staff Credit Union Limited, (hereafter referred to as "Qantas").

*Interpretation*

4. In this Order:

- (a) "daily percentage rate" means the rate determined by dividing the annual percentage rate disclosed on the contract, or as subsequently varied, by the number of days in the year in which the daily percentage rate is used;
- (b) "daily unpaid balance of the loan" means the balance at the end of each day and such a balance may include an amount of credit charge that has accrued, Stamp Duty, Financial Institutions Duty, Bank Accounts Debit Tax, an enforcement expense, an establishment fee charged in accordance with the Credit (Credit Society Establishment Fees) Order or a legal and valuation fee charged in accordance with the Credit (Credit Society Legal and Valuation Fees) Order;
- (c) A reference in this Order to "Stamp Duty" or "Financial Institutions Duty" shall include a reference to stamp duty or Financial Institutions Duty under the laws of the State or Territory incurred in relation to a regulated loan contract.

5. Subject to clause 6 for the purpose of the Credit Act 1984 a loan contract does not fail to comply with the Act by reason only that the method of calculating the annual percentage rate is not calculated in accordance with section 38 of the Act or the accrued credit charge is not in accordance with a method set out in section 11 of the Act.

6. The exemption in Clause 5 of this Order only applies where the annual percentage rate and accrued credit charge in relation to a loan contract are calculated in accordance with Clause 7 of this Order.

*Calculation of Annual Percentage Rate*

7. (1) Provided:

- (a) Qantas does not charge a default or deferral charge as specified in sections 71 and 72 of the Credit Act 1984; and
- (b) the accrued credit charge is calculated in accordance with Clause 7 (2) of this Order;

the annual percentage rate with respect to a loan contract may be calculated by the following method;

where under the contract the whole of the credit charge for any period is determined by the application of a percentage rate per annum to the average daily unpaid balance of the loan, multiplied by the number of days in the relevant period and then divided by the number of days in the relevant year, the annual percentage rate shall be that rate.

*Calculation of Accrued Credit Charge*

(2) The accrued credit charge with respect to a loan contract may be calculated by the following method:

the amount of credit charge which has accrued at a particular time may be calculated by adding together the amounts ascertained by applying the daily percentage rate to the daily unpaid balance of the loan.

*Disclosure—Previous Loan Balances*

8. Subject to clause 9, a loan contract does not fail to comply with the Credit Act by reason only that it does not include in the statement of the amount financed, in accordance with clause 1 (e) of Schedule 4 to the Act, statements showing separately the amounts that are the consideration for the discharge of the liability of the debtor to Qantas under two or more previous contracts.

9. The exemption in clause 8 only applies:

- (1) in relation to the first loan contract to be entered into after the commencement date of this order which purports to pay out two or more previous contracts between Qantas and the debtor; and

(2) on condition that the loan contract includes a statement specifying the total amount that is the consideration for the discharge of the liability of the debtor to Qantas in respect of two or more previous contracts.

10. It is sufficient compliance for the purpose of clause 4 (2) of the Credit Society (Transitional) Exemption Order No. 2 if there is disclosure of the total outstanding balance owed by the debtor to Qantas in respect of two or more loan contracts which are being paid out by a loan contract referred to in clause 9 (1) above.
