Shop Trading Act 1987 PROCLAMATION

Substitution of an Ordinary Closing
Day—"Geelong Urban Area"

I, Richard E. McGarvie, Governor of
Victoria, acting with the advice of the Executive
Council and under section 5 (3) of the **Shop
Trading Act 1987**:

- (1) Declare that Wednesday, 18 October 1995, shall not be an ordinary closing day in relation to certain shops situated within the "Geelong Urban Area", defined in section 5 (4) of the Act as the 'Cities of Geelong, Geelong West and Newtown, the Shire of Corio, the Highton, Belmont and Grovedale Wards of the City of South Barwon, the township of Leopold and that part of the Shire of Bellarine within Boundary Road, Moolap Station Road, the southern shore of Corio Bay, Reedy Lake and the Barwon River; and
- (2) Appoint Wednesday, 25 October 1995, as an ordinary closing day in relation to shops situated within the "Geelong Urban Area" except shops for the sale of motor cars and exempt shops in substitution for the day referred to in (1).
