WATER ACT 1989

I, Charles Geoffrey Coleman, as Minister administering the Water Act 1989, make the following Order:

AMENDMENT TO THE CONSTITUTION OF THE PORTLAND COAST REGION WATER AUTHORITY ORDER 1995 No. 1

1. This Order is called the Amendment to the Constitution of the Portland Coast Region Water Authority Order 1995 No.1.

2. This Order is made under the powers conferred by Division 2 of Part 6 of the Water Act 1989 and all other available powers.

3. This Order takes effect on 1 February 1995.

4. This Order amends the Constitution of the Portland Coast Region Water Authority Order 1994 published in the Government Gazette No.S 42 of 1 July 1994 ("the Original Order").

I, Charles Geoffrey Coleman, as Minister administering the Water Act 1989, make the following Order:

CONSTITUTION OF THE GRAMPIANS REGION WATER AUTHORITY ORDER 1995

1. Citation

This Order is called the Constitution of the Grampians Region Water Authority Order 1995.

2. Enabling Powers

This Order is made under the powers conferred by Division 2 of Part 6 of the Water Act 1989 and all other available powers.

3. Date of Effect

This Order takes effect on and from 1 February 1995.

4. Definitions

In this Order:

"Act" means the Water Act 1989.

"Former Authorities" means the:

- Buloke Shire Council which was constituted as the successor body to the Birchip Shire and others by Order published in the Government Gazette on 20 January 1995.

The Shire of Birchip was constituted as a water authority by an Order published in the Government Gazette on 28 September 1983.

- Hindmarsh Water Board which was constituted as a water authority by an Order published in the Government Gazette on 19 December 1984.

- Horsham Water Board which was constituted as a water authority by an Order published in the Government Gazette on 3 October 1994.

- West Wimmera Shire which was constituted as the successor body to Kaniva Shire and others by an Order published in the Government Gazette on 20 January 1995.

The Shire of Kaniva was constituted as a water authority by an Order published in the Government Gazette on 28 September 1983.

- Murtoa Water Board which was constituted as a water authority by an Order published in the Government Gazette on 30 November 1983.

- Nhill Water Board which was constituted as a water authority by an

- Sea Lake Water Board which was constituted as a water authority by an Order published in the Government Gazette on 13 June 1984.

Stawell Shire was constituted as a water authority by an Order published in the Government Gazette on 21 December 1983.
- Stawell Water Board which was constituted as a water authority by an Order published in the Government Gazette on 6 June 1984.
- Rural City of Mildura which was constituted as the successor body to the Walpeup Shire and others by an Order published in the Government Gazette on 20 January 1995.
Walpeup Shire was constituted as a water authority by an Order published in the Government Gazette on 27 June 1984.
- Warracknabeal Water Board which was constituted as a water authority by an Order published in the Government Gazette on 28 September 1983.
- Wycheproof Water Board which was constituted as a water authority by an Order published in the Government Gazette on 13 June 1984.

5. Constitution of Grampians Region Water Authority

On and from the date on which this Order takes effect:

- (a) there is constituted a new Authority; and
- (b) the corporate name of the new Authority is the Grampians Region Water Authority.

6. Takeover of Former Authorities

On and from the date on which this Order takes effect the new Authority constituted by Clause 5 of this Order takes over the whole of

9. Chairperson of the Grampians Region Water Authority

The Chairperson of the new Authority constituted in clause 5 of this Order is to be appointed by the Minister in writing.

10. Abolition

The Former Authorities are abolished.

11. Pre-requisites for Making This Order

(a) This is an Order referred to in section 98 (2) (a) of the Act.

(b) Under section 100 (2) (a) of the Water Act 1989 the Former Authorities have applied to me for the Order to be made.

(c) Under section 98 (2) (a) of the Act I have agreed the terms and conditions for the take over made by this Order with the affected Authorities.

1. Citation

This Order is called the Constitution of the Lower Murray Region Water Authority Order 1995.

2. Enabling Powers

This Order is made under the powers conferred by Division 2 of Part 6 of the Water Act 1989 and all other available powers.

3. Date of Effect

This Order takes effect on and from 1 February 1995.

4. Definitions

In this Order:

“Act” means the Water Act 1989.

“Former Authorities” means the:

Sunraysia Water Board constituted by an Order in Council dated 26 June 1984 and published in the Government Gazette on 27 June 1984.

Robinvale Water Board constituted by an Order in Council dated 26 June 1984 and published in the Government Gazette on 27 June 1984.

Shire of Gannawarra constituted as the successor body to the Borough of Kerang and other bodies by an Order published in the Government Gazette on 20 January 1995. The Borough of Kerang was constituted as a water authority by an Order in Council dated 20 September 1984 and published in the Government Gazette on 28 September 1984.

5. Constitution of Lower Murray Region Water Authority

On and from the date on which this Order takes effect:

(a) there is constituted a new Authority; and

(b) the corporate name of the new Authority is the Lower Murray Region Water Authority.

6. Takeover of Former Authorities

On and from the date on which this Order takes effect the new Authority constituted by Clause 5 of this Order takes over:

(a) the whole of the property, rights, liabilities, obligations, powers and functions of the Former Authorities under the Act in respect of the following districts:

7. Transfer of Staff

The new Authority takes over the staff of the Former Authorities as listed:

8. Membership of the Lower Murray Region Water Authority

The membership of the new Authority constituted in Clause 5 of this Order is seven members appointed by the Minister in writing.

9. Appointment of Chairperson

The Chairperson of the Lower Murray Region Water Authority is to be appointed by the Minister in writing.

10. Abolition

The Former Authorities are abolished.

11. Pre-requisites for Making This Order

(a) This is an Order referred to in section 98 (2) (a) of the Act.

(b) Under section 100 (2) (a) of the Act the Former Authorities have applied to me for the Order to be made.

(c) Under section 98 (2) (a) of the Act I have agreed the terms and conditions for the take over made by this Order with the affected Authorities.

1. Citation

This Order is called the Transfer of Works to the Coliban Region Water Authority Order 1995 No. 1.

2. Enabling Powers

This Order is made under the powers conferred by Division 2 of Part 6 of the Water Act 1989 and all other available powers.

3. Date of Effect

This Order takes effect on the date on which it is published in the Government Gazette.

4. Definitions

In this Order:

“Act” means the Water Act 1989.

“Authority” means the Coliban Region Water Authority.

“Body” means the Shire of Loddon constituted as the successor body to the Shire of Korong and other bodies by an Order published in the Government Gazette on 19 January 1995.

5. Appointment of Coliban Region Water Authority

On and from the date on which this Order takes effect all the works used by the Shire of Loddon in performing its functions and exercising its powers under the Local Government Act 1989 in respect of the Mysia Water Supply, Wychitella Water Supply and Borung Water Supply systems are transferred to the Authority.

8. Pre-requisites for Making this Order

(a) This is an Order referred to in section 98 (3) (a) of the Act;

(b) Under section 98 (4) (a) of the Act I have agreed the terms and conditions for the transfer made by this Order, with the Authority and the Body;

(c) Under section 100 (2) (a) of the Act the affected Authority and Body have applied to me for the Order to be made;

(d) Under section 100 (2) (b) of the Act I have consulted with the Minister administering the Local Government Act 1989 as a Council is affected; and

(e) Under section 98 (4) (b) of the Act I am satisfied that appropriate provisions have been made in relation to the disposition of the works, the rights and liabilities of the Shire of Loddon and the manner of repayment of any money borrowed in respect of the works.
