Notice of Decision

I, Haddon Storey, Minister for Gaming give notice under section 12 of the **Subordinate Legislation Act 1994**, that I have decided that the proposed Lotteries Gaming and Betting (Raffles and Bingo Permits) (Miscellaneous) Regulations 1995 be made.

A Regulatory Impact Statement was prepared and advertised inviting public comment and submissions. One submission was received which was supportive of the proposed Regulations.

Amendments have been made to the form of the proposed regulations on the advice of Parliamentary Counsel. The amendments are of a technical nature and do not alter the impact of the proposed regulations.
