ORDER APPOINTING A COMMISSIONER
OF THE GREATER BENDIGO CITY

The Governor in Council acting under Part 10C of the Local Government Act 1989 ORDERS THAT:

- (2) Janice Bateman is appointed a Commissioner of the Maroondah City Council.
- (3) Carmen Watson is appointed a Commissioner of the Yarra City Council.

A person appointed under clause 2 is appointed from the day this Order comes into operation until 9.00 a.m. on the day on which the first meeting of the Council to which that person is appointed is held following the first election of Councillors for that Council.
