Electricity Industry Act 1993 NOTICE UNDER SECTION 165 VARIATION OF LICENCES

SCHEDULE 2

The Licensee must, by 30 June 1995, enter into a contract entitled Generator Co-Insurance

Scheme Contract in a form certified by the Treasurer and expiring no later than 30 September 1996."
