Subordinate Legislation Act 1994 MINERAL RESOURCES (HEALTH AND SAFETY IN LARGE OPEN-CUT MINES) REGULATIONS 1995

Notice of Preparation of Regulatory Impact Statement

Notice is given under section 11 of the Subordinate Legislation Act 1994, that a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Mineral Resources (Health and Safety in Large Open-Cut Mines) Regulations 1995.

The objective of the proposed Regulations is to secure, as far as is reasonably practicable, the health and safety of all persons in, on or about the open-cut mines operating within Victoria to which these Regulations apply.

It is the intention of the Government that the three open-cut brown coal Mines in the Latrobe Valley (Morwell, Yallourn and Loy Yang) come under the operation of the Mineral Resources Development Act 1990 ("MRD Act"). As licensees under the MRD Act, the Mines will be exempt from the operation of the Occupational Health and Safety Act 1985 and its subordinate legislation.

A new set of regulations has been prepared to apply to work carried out on or above these mines. The existing Mineral Resources (Health and Safety) Regulations 1991 will not apply.

Performance-based regulations were selected as the preferred method of regulation due to the substantial safety management systems existing in all three Mines. The proposed regulations provide objective standards which emphasise the most significant aspects of health and safety in the industry.

The proposed Regulations will provide Licensees with greater flexibility in the implementation of health and safety programs and thereby allow cost-efficient compliance

measures to be adopted. Through worker involvement, enforceability of standards and incentive for innovation, the proposed regulations encourage improvements in health and safety standards and lower risks to workers and the environment.

The costs and benefits of the proposed Regulations are outlined in the RIS. The RIS concludes that the benefit/cost analysis clearly demonstrates the net benefits associated with this proposal and that the proposed regulations offer the best solution.

Alternatives to the proposed Regulations which were examined in the RIS were a new set of prescriptive regulations specifically for the La Trobe Valley Mines and self-regulation. The alternative of prescriptive regulations was rejected due to its inflexibility, failure to encourage improvements in health and safety and significant net cost. Self-regulation was rejected because of the possibility that the level of Health and Safety Standards would not be maintained and because of the net costs it imposes on the community.
