Accident Compensation (WorkCover Insurance) Act 1993 WORKCOVER INSURANCE PREMIUMS ORDER (No. 2) 1994/95

Under and for the purposes of Item 1 of Schedule 3 to the WorkCover Insurance Premiums Order (No. 2) 1994/95 the Victorian WorkCover Authority has determined that the values of F_0^c , F_1^c , F_2^c , for the purpose of calculating the Experience Factor, E, for a period of coverage of a workplace, are respectively the relevant numbers specified in the following Table, opposite the authorised insurer which calculated the costs of claims of the workplace:
