Markets Local Law No. 2

Environment Local Law No. 3

Streets, Roads and Other Public Places  
 Local Law No. 4

to provide for the regulation of activities within the municipal district of the City.

The purposes (objectives) of the respective proposed local laws are:

**Markets Local Law No. 2**

The objectives of this Local Law are:

- (a) to regulate markets within the municipal district;

- (b) to prohibit, regulate or control the sale of goods from stalls, motor cars, carts, trucks, barrows, baskets, crates, bags, stands, boxes, shelves, pavements or other vehicles or receptacles standing or placed in a market;
- (c) to regulate or control the area or areas which may be used for purposes of markets and to prohibit the establishment or operation of markets other than in areas authorised by Council for the purpose of markets;
- (d) to fix the days and the hours during which markets may be conducted and open to the public which days and hours may be varied depending upon the market to which they relate;
- (e) to prevent the sale or exposure for sale of unwholesome provisions in any market;

- (f) to regulate the occupation of any area set aside or set aside during specified periods for market purposes;
- (g) to issue licences and charge licence fees or stallage fees or dues in respect of rights to use areas or facilities within areas available for use as a market;
- (h) to provide a safe and healthy environment in which markets may be conducted and regulate safety, health, signage, structures, cleanliness, rubbish removal and activities;
- (i) to provide the provision of this local law to lessees at the South Melbourne Market;
- (j) to provide for the peace order and good government of the Municipal District; and
- (k) to repeal redundant local laws.

Environment Local Law No. 3

The objectives of this Local Law are:

- (a) to provide a safe and healthy environment in which the residents of the municipal district enjoy a quality of life that meets the general expectations of the community; and
- (b) to prohibit, regulate and control activities which may be dangerous or unsafe or detrimental to the quality of life in an environment of the municipal district; and
- (c) to facilitate the provision of general public services, health and other community services, property services, recreational and cultural services, sale of goods and other services in a way which enhances the environment and quality of life in the municipal district; and
- (d) to control nuisances and noise, odour and smoke emissions, and other discharges to the environment and which may adversely affect the enjoyment of life within the municipal district or the health, safety and welfare of persons within the municipal district; and
- (e) in a way which is consistent with, and in furtherance of, the objectives specified in paragraphs (a) to (d) of this clause to prohibit, regulate and control activities and circumstances associated with—

- (i) smoke emission, particularly emission from burning material and from chimneys; and
  - (ii) the use of recreational vehicles, particularly vehicles which are not used on appropriate land or reserves or which emit excessive noise or air pollution; and
  - (iii) fire hazards; and
  - (iv) dangerous and unsightly land; and
  - (v) swimming pools; and outdoor spas
  - (vi) advertising, bill posting and junk mail; and
  - (vii) camping and temporary dwellings; and
  - (viii) circuses, carnivals and festivals; and
  - (ix) water quality, including interference with water courses; and
  - (x) animals, including animal numbers and the keeping, housing and control of animals; and
  - (xi) disposal of waste and use and location of water containers; and
  - (xii) prohibiting or minimising noises in any highway; and
  - (xiii) suppressing nuisances; and
  - (xiv) controlling and regulating the use of buildings and premises with a view to preventing objectionable noises at unreasonable times; and
  - (xv) protecting the residential amenity; and
- (f) (i) to provide for the regulation of the collection of used clothing and other goods in recycling bins;
- (ii) to ensure that residents and other persons who wish to make clothing and other goods available for the purposes of charities are able to do so and for that purpose to minimize or eliminate the possibility that such persons might be deceived as to the purposes for which donated clothing and goods are to be put;
  - (iii) to establish a system of control for the location in the municipal district of recycling clothing bins used by certain charities to ensure—

- \* that recycling clothing bins are located on sites which are easily accessible and visible to the public;
  - \* that the sites on which the bins are located are kept in a clean condition and that the amenity of the area is not affected by their presence;

- (b) to provide for the peace, order and well being of people in the municipal district and for a distance extending across the beach and foreshore waters to an imaginary line 100 metres seaward from the high water mark from time to time;
- (c) in Part 5—
- (i) to provide for the physical features of the road and adjacent properties to be managed in a way which attends to the safety and convenience of people travelling on or using the road (whether on foot or by vehicle);
  - (ii) to establish mechanisms for adequate consultation to accompany major changes to traffic arrangements; and

(d) in Part 6—

- (i) to control various types of vehicles and animals for the safety and convenience of road users;
- (ii) to preserve and protect as far as possible the Council's assets from damage which may be caused from extraordinary use of streets roads and other public places within the municipal district; and

(e) in Part 7—

- (i) to control and regulate secondary activities on roads including—
  - (i) trading;
  - (ii) the placing of goods and equipment;
  - (iii) repairs to vehicles; and
  - (iv) parties, festivals and processions—
 in a fair, equitable and safe manner which does not compromise the primary need for the passage and repassage of people and goods; and
- (ii) to provide free and safe access for people with sight and movement impairment or disabilities; and

(f) in Part 8—

- (i) to prohibit, regulate and control advertising signs, displays of goods for sale, and the provision of outdoor eating facilities; and

(g) in Part 9—

- (i) to regulate the use of reserves and other public places;
- (ii) to regulate filming for commercial or public exhibition; and
- (iii) to enable the Council to designate areas and times during which alcoholic beverages may not be taken into such areas or may not be consumed or possessed in an unsealed container in such designated areas;

(h) in Part 10—

- (i) to regulate the use of the beach and the foreshore waters;
- (ii) to designate areas in which devices (sailboards, jetskis, surf skis, surfboards, skiffle boards, boats) may be transported, located or used or in which devices may not be transported, located or used;

- (iii) to regulate the selling or hiring of goods or services or other activities related to the selling or hiring of goods or services; and
- (i) to repeal local laws which become redundant upon the making of this local law.

The general purpose of the proposed local laws includes specification of what form of regulation is proposed with a view to achieving the stated objectives in each local law. It is proposed that certain activities may not be undertaken at all or without a permit (or exemption or licence), allows for conditions and fees to apply to permits (or licences) and for conditions to apply to any exemptions. It allows for the issue of notices to comply in certain circumstances such as where conditions of a permit are not being met and provides for authorised officers to prosecute offences either by the issue of infringement notices or by Court procedure. The proposed local laws set standards to be followed in exercising discretions and repeals a number of redundant local laws of former Councils.

The proposed local law if made would apply to the whole of the municipal district except in those circumstances where its provisions apply to a localised area (such as an area of beach access for surf skis) and allows for designation of further areas by resolution of Council with appropriate notice and signposting. The aim is for better regulation of activities within the municipal district within Markets on the beach and in foreshore waters with a view to consideration of the welfare of the whole community.

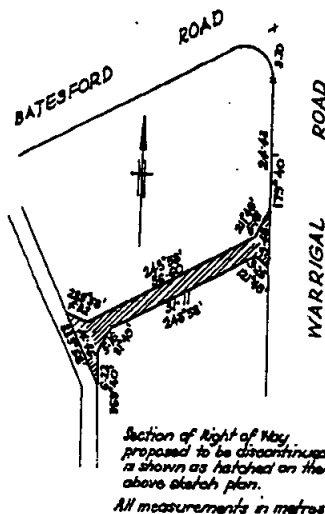

**Local Law No. 7—Municipal Places**

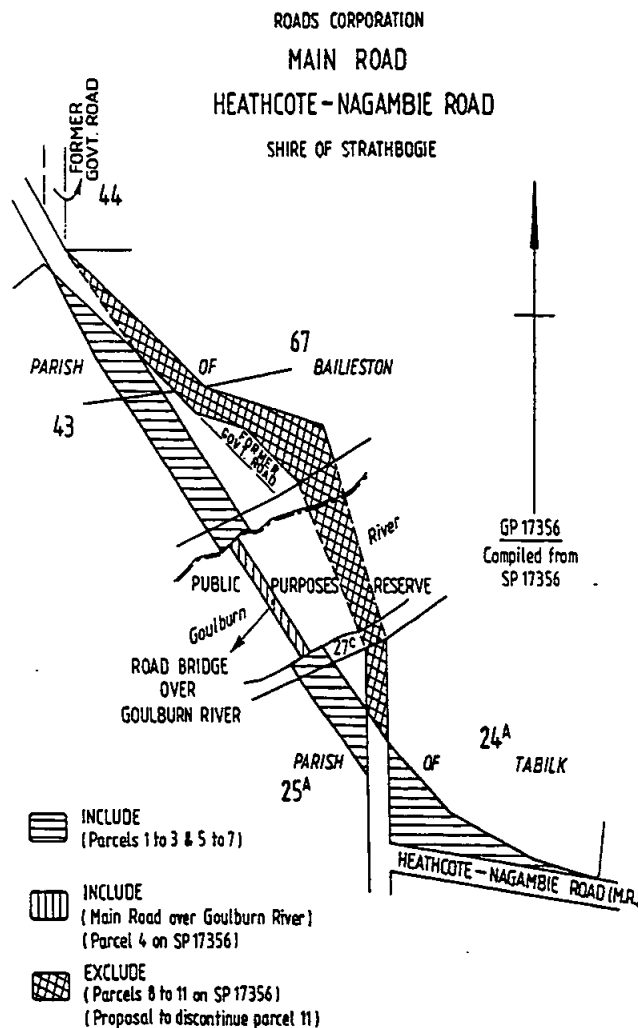

Emergency Services Superannuation Scheme  
(Amendment) Regulations 1995**

Notice is given in accordance with section 11 of the Subordinate Legislation Act 1994, that a Regulatory Impact Statement (RIS) has been prepared in relation to the Emergency Services Superannuation Scheme (Amendment) Regulations 1995.

The reason for the proposed Regulations results from a review of public sector superannuation by the Victorian Government and an agreement arising out of that review entered into between the Minister for Finance for the State of Victoria, the Police Association, the United Fire Fighters Union of Australia (Victorian Branch) and the Ambulance Employees Association of Victoria.

The objectives to be achieved by the Regulations are to implement certain specific alterations agreed to in relation to the arrangements of the Emergency Services Superannuation Scheme (ESSS) and these are summarised as follows—

- (a) amendments to reduce the rate of benefit accrual and reduce the maximum benefit multiple in ESSS in order to accommodate any change in the taxation status of ESSS;
- (b) amendments to ensure that all pensions payable under the ESSS are adjusted in accordance with the All Capital Cities Consumer Price Index for the relevant year;
- (c) amendments to adjust the calculation of death and disability benefits payable to ensure that, in the case of operational members, the future service component included in benefit calculations will include potential service to age 55, and for non-operational members, the future service component included in benefit calculations will include potential service to age 60;
- (d) amendments to ensure that transferred members under the Emergency Services Superannuation Act 1986 (ESSA) will be entitled to contribute up to a maximum optional 8% member contribution rate deemed to apply from 1 January 1994;
- (e) amendments to ensure that all operational members (other than transferred members) under ESSA will be entitled to contribute an average 7% member contribution rate over 30 years service to achieve the maximum benefit multiple;
- (f) amendments to ensure that all non-operational members (other than transferred members) under ESSA will be able to contribute up to a maximum optional 5% member contribution rate deemed to apply from 1 January 1994;
- (g) a phasing in of amendments to ensure that benefits will be calculated on the basis of final average salary over the last two years of service.

The RIS detailed the benefits of the Regulations, being principally clarity, efficiency and certainty in operation of the ESSS which far outweigh the costs of the Regulations, which are negligible. In addition all operational and transferred members will be treated in the same way, given the new arrangements will be embodied in Regulations.

If the Regulations were not made, there would be considerable confusion in the operation of the ESSS in relation to payment of benefits in general. Specifically, provisions of the Principal Regulations would be contradicted by provisions in prevailing legislation. In addition, the provisions of the Agreement would not be reflected in the regulatory framework. Consequently, contributions and benefits may not be paid in accordance with the Agreement, which would not be desirable.

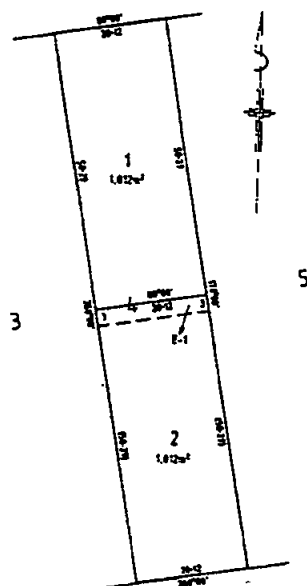

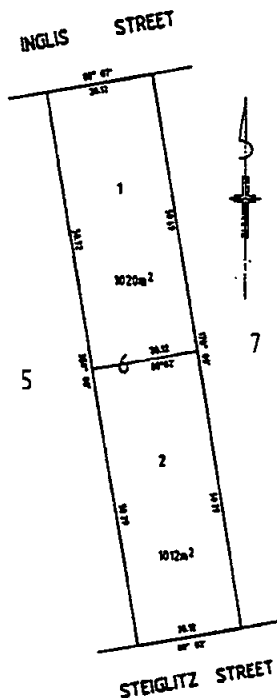

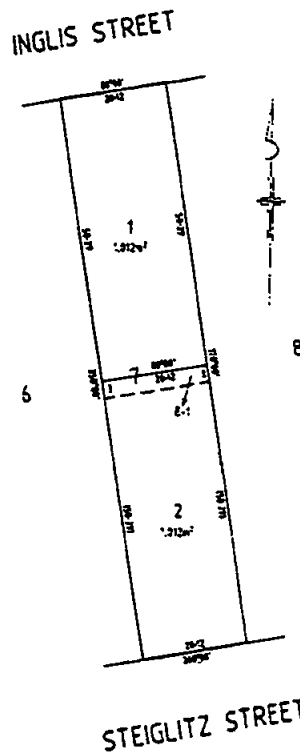

2. In these Rules, the Victorian Casino and Gaming Authority Rules 1991\* are called the Principal Rules.

*New Rule*

3. After Rule 19 of the Principal Rules, insert—

"Competitions ancillary and incidental to conduct of gaming (EGM tournaments)

20. (1) A venue operator must not promote any competition that is ancillary or incidental to the conduct of gaming at the venue unless the competition complies with this rule.

- (2) Any competition under this rule must:
- (a) provide all players with an equal chance of winning each prize; and
  - (b) provide for all players to contribute equally to the prize pool; and
  - (c) distribute all contributions into the prize pool:
    - (i) from participants in the competition; and
    - (ii) from any other party (or advertised to be contributed by any other party); and
  - (d) in respect of the collection and distribution of the prize pool, be conducted ancillary to gaming and as such not form part of any calculation under sections 135 or 136 of the **Gaming Machine Control Act 1991**; and
  - (e) distribute the prize pool on the basis of the result of monitored gaming machine play in which all participants gamble on the electronic gaming machines using gaming machine credits established with the players' own funds; and
  - (f) provide for each player to collect that person's gaming machine credit balance at the conclusion of the competition.

3. A venue operator must ensure that each participant in any competition under this rule is aware, prior to accepting the participants entry fee, of:

- (a) the amount of the participant's fund to be used to establish gaming machine credits; and
- (b) the amount of the participant's contribution to the prize pool; and
- (c) the rules for determining the distribution of the prize pool.

4. Entry fees into the competition from all participants must be collected by the venue operator prior to commencement of the competition.

5. A venue operator must advise the Authority, in writing, at least one week prior to conducting a competition under this rule, of:

- (a) the date and time and location of the competition; and
- (b) the projected number of players; and
- (c) the amount of the projected prize pool; and

- (d) the amount of the prize pool made up by player contribution; and
- (e) the amount of and source of any other funds in the prize pool."

#### ORDER ALTERING THE BOUNDARIES OF THE MUNICIPAL DISTRICTS OF THE BALLARAT CITY COUNCIL AND THE GOLDEN PLAINS SHIRE COUNCIL

WHEREAS the Minister for Local Government has certified to the Governor in Council that—

- (a) the proposed boundary change is of a minor nature;
- (b) the Ballarat City Council and the Golden Plains Shire Council whose municipal districts are affected by the proposed change, have approved of the proposed change; and
- (c) public notice of the proposed change was given in the municipal districts of the Ballarat City Council and the Golden Plains Shire Council.

(2) The amount of \$501758400 which was appropriated by the **Appropriation (1994–95, No. 1) Act 1994** for works and services of the Department of the Treasury may, to the extent to which it has not been issued and applied, be issued and applied for works and services of the Department of Treasury and Finance carried out in the performance of the functions of the superseded Department of the Treasury.
7. (1) The amount of \$178291300 which was appropriated by the **Appropriation (1994–95, No. 1) Act 1994** for recurrent services of the Department of Finance may, to the extent to which it has not been issued and applied, be issued and applied for recurrent services of the Department of the Treasury and Finance carried out in the performance of the functions of the superseded Department of Finance.  
(2) The amount of \$51474900 which was appropriated by the **Appropriation (1994–95, No. 1) Act 1994** for works and services of the Department of Finance may, to the extent to which it has not been issued and applied, be issued and applied for works and services of the Department of the Treasury and Finance carried out in the performance of the functions of the superseded Department of Finance.
8. In this Order—

“The Act” means the **Administrative Arrangements Act 1983**.

“Body” means Minister, Department or Officer.

“Instrument” includes contract and agreement.

“Old Body” and “New Body” mean respectively the Bodies specified in Column 1 and Column 3 of each item in Schedule 1.

“Schedule” means Schedule to this Order.

“Transaction” includes—

  - (a) Agreement, bond, contract, deed or other consensual arrangement whatsoever;
  - (b) Action, appeal, arbitration, prosecution and other legal proceeding whatsoever;
  - (c) Assignment, charge, lease, mortgage, transfer or other dealing with property whatsoever;
  - (d) Loan, guarantee, indemnity or other dealing with money whatsoever;
  - (e) Approval, consent, delegation, direction, licence, Order, permit, requirement or other authority whatsoever;



- (f) Notice; and  
 (g) Any other act, entitlement or liability in the law whatsoever.

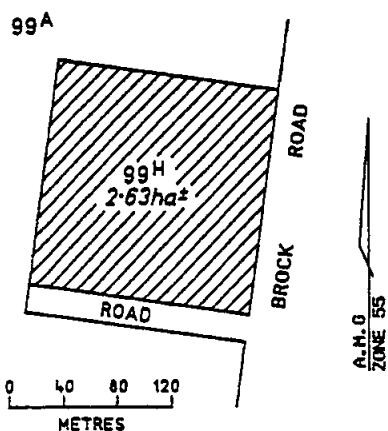
