

 - (b) to establish mechanisms for adequate consultation to accompany major changes to traffic arrangements and the discontinuation of roads;
- (4) in Part 6:
 - (a) to control various types of vehicles and animals for the safety and convenience of road users; and
 - (b) to preserve and protect as far as possible the Shire's assets from damage which may be caused from extraordinary use of roads within the Municipal District;
- (5) in Part 7:
 - (a) to control and regulate secondary activities on roads including:
 - (i) trading;
 - (ii) the placing of goods and equipment;
 - (iii) repairs to vehicles; and
 - (iv) parties, festivals and processions; and
 - (v) busking and collections in a fair, equitable and safe manner which does not compromise the primary need for the passage of people and goods; and
 - (b) to provide unimpeded and safe access for people with sight and movement impairment or disabilities:
- (6) in Part 8
 - (a) to provide for the safe and efficient management and control of parking on roads in the Municipal District; and
 - (b) to provide mechanisms to manage and control parking so as to cause minimal disruption, danger or nuisance to the users of the Shire's parking facilities;

- (7) to allow and protect the quiet enjoyment by people of Municipal places within the Municipal District;
- (8) to enable people in the Municipal District to carry out their day to day activities and to enjoy their recreational pursuits without having their peace and enjoyment interfered with or destroyed;
- (9) to recognise and respond to community expectations relating to the quality of life they expect and require and are capable of influencing;
- (10) to control and prevent behaviour which is a nuisance, or which may be detrimental to health and safety or which affects the enjoyment of recreational or other facilities;
- (11) to enable the community and visitors and their families who use Municipal places that are available to the public to be confident in their choice of the use of those facilities or places;
- (12) to protect Council and community assets and facilities on or in Municipal places;
- (13) in a way which is consistent with, and in furtherance of, the purposes specified in sub-clauses (7) to (12) of this clause to prohibit, regulate and control:
 - (a) behaviour in Municipal places which is boisterous, offensive, intimidating, dangerous or threatening or which, for other reasons, is inappropriate in a Municipal place; and
 - (b) the places and times at which alcohol may be consumed;
- (14) to provide a safe and healthy environment in which the residents of the Municipal District enjoy a quality of life that meets the general expectations of the community;
- (15) to prohibit, regulate and control activities which may be dangerous or unsafe or detrimental to the quality of life in an environment of the Municipal District:
- (16) to facilitate the provision of general public services, health and other community services, property services, recreational and cultural

services and other services in a way which enhances the environment and quality of life in the Municipal District;

- (17) to control nuisances and noise, odour and other discharges to the environment which may adversely affect the enjoyment of life within the Municipal District or the health, safety and welfare of persons within the Municipal District;
- (18) in a way which is consistent with, an in furtherance of, the purposes specified in sub-clauses (15 to (18) of this clause to prohibit, regulate and control activities and circumstances associated with:
 - (a) dangerous and unsightly land;
 - (b) storage of machinery, second hand vehicles and second hand goods;
 - (c) smoke emissions (particularly from chimneys) and incinerators;
 - (d) advertising, bill posting and junk mail;
 - (e) camping and temporary dwellings;
 - (f) circuses, carnivals and festivals;
 - (g) interference with water courses;
 - (h) animals and birds, including animal numbers and the keeping and control of animals and birds;
 - (i) disposal of waste including behaviour associated with tips;
 - (j) drainage tapping; and
 - (k) smoking in Municipal properties;
- (19) (a) to provide for the regulation of the collection of used clothing and other goods in recycling bins;
 - (b) to ensure that residents and other persons who wish to make clothing and other goods available for the purposes of charities are able to do so and for that purpose to minimise or eliminate the possibility that such persons might be deceived as to the purposes for which donated clothing and goods are to be put;
 - (c) to establish a system of control for the location in the municipal district of recycling clothing bins used by certain charities to ensure: that recycling clothing bins are located

on sites which are easily accessible and

visible to the public;

that the sites on which the bins are located are kept in a clean condition and that the amenity of the area is not affected by their presence;

that the bins are located in a way that they do not cause an obstruction or a potentially dangerous situation; and

that a nuisance is not caused to owners or occupiers or users of land on which bins are located or land adjacent;

- (20) to provide for the administration of the Council's powers and functions; and
- (21) to repeal redundant Local Laws.

The general purport of the Local Law includes specification of the form of regulation with a view to achieving the stated objectives. Its aim is to clarify expected standards of conduct within the municipal district to address the welfare of the whole community. In attempting to achieve this aim, it also addresses the environment, streets and roads and community properties, prohibits the doing of acts which would be likely to be detrimental to the general community or to the municipal district and regulates other activities by making them subject to obtaining a permit or exemption from Council and complying with any conditions.

In many instances, it provides for the issue of a Notice to Comply with the local law setting out what needs to be done and within what time. It allows for certain goods and animals to be impounded, provides procedures for recovery of those goods or animals, provides standards guiding the use of some discretions of Shire officers and authorises officers to pursue penalties for non compliance either by infringement notices or by Court prosecution.

A copy of the Local Law may be inspected at or obtained from the Shire's Morwell, Moe or Traralgon Office.

The Local Law operates from 26 October 1995.



PLAN OF DISCONTINUED ROAD





The general purport of the amendment is to create the above prohibition during the time mentioned and to constitute an offence for acting contrary to such prohibition which may be prosecuted in Court or by issue of an infringement notice.

Regulation 724 of the Road Safety (Vehicles) Regulations 1988 authorises the Roads Corporation, by notice in the Victoria Government Gazette, to allow vehicles which exceed mass or dimension limits prescribed in the Regulations to be used on roads.

Under Regulation 724, I, Tony Fry, delegate of the Roads Corporation, allow vehicles and combinations, except B-doubles and road trains, carrying bulk grain, grain legumes or oil seeds by the shortest reasonable route from the place of harvest to the nearest receiving VICGRAIN Limited local silo or central receival point or other receival points approved by the Roads Corporation, to exceed a mass limit prescribed in Division 2, Part 7 of the Road Safety (Vehicles) Regulations 1988 to travel on roads as described in Part 1 of this permit if they comply with all the mass limits in Part 2 and the operating conditions in Part 3.

This notice is effective from 2 November 1995 until 31 December 1995. However, if any of the conditions in this notice are breached, the notice is invalid in relation to the vehicle the subject of the breach, and (depending on what the breach is), the owner and the driver of the vehicle or combination and any person who caused or permitted it to be used on a road, may be prosecuted for exceeding the mass limits in Division 2, Part 7 of the Road Safety (Vehicles) Regulations 1988.

PART 1

Roads

- 1.1 (1) Travel is permitted on any roads that have been declared under Schedule 5 of the Transport Act 1983.
- 1.1 (2) Travel is allowed on a road that has not been declared under Schedule 5 of the **Transport Act 1983** if the road is along the most direct and

practical route between the point of pick-up and delivery, and a road that has been declared under Schedule 5 of the **Transport Act 1983**.

1.1 (3) In spite of subclauses (1) and (2), a vehicle or combination must not travel on a road, bridge or structure where any posted mass limit would be exceeded.

PART 2

Vehicle and Combination Mass Limits

2.1 (1) A vehicle or combination may operate up to the mass limits in Part 1 of the Schedule in the Road Transport Reform (Mass and Loading) Regulations 1995 (Statutory Rules 1995 No. 56), which are summarised in VicRoads' Heavy Vehicle Reform information bulletin No. 7 dated September 1995, and is available at VicRoads' offices.

PART 3

Operating Conditions

3.1 (1) Any trip hereby permitted is made at the vehicle owner's and driver's risk absolutely. No representation is made by the Roads Corporation that any road, bridge, culvert, causeway or grid is capable of withstanding the vehicle or combination.

PART 4 Definitions

4.1 (1) In this notice:

"B-double" means a combination of vehicles consisting of a prime mover towing two semi-trailers.

"converter dolly" means a trailer with one axle group or single axle and a fifth wheel coupling designed to convert a semi-trailer into a dog trailer.

"dog trailer" means a trailer (including a trailer consisting of a semi-trailer and converter dolly) with:

- (a) one axle group or single axle at the front that is steered by connection to the towing vehicle by a drawbar; and
- (b) one axle group or single axle at the

"drawbar" means a part of a trailer (other than a semi-trailer) that connects the trailer body to a coupling for towing purposes.

"fifth wheel coupling" means a device, other than the upper rotating element and the kingpin (which are parts of a semi-trailer), used with a prime mover, semi-trailer or a converter dolly to permit quick coupling and uncoupling and to provide for articulation.

"load", in relation to a vehicle, includes anything that is normally removed from the vehicle when the vehicle is not in use.

"operator" means a person who controls or directs the operations of a vehicle or who is otherwise responsible for it.

"owner", in relation to a vehicle, means:

- (a) if the vehicle:
 - (i) is registered—a person in whose name the vehicle is registered under a Commonwealth, State or Territory Act; or
 - (ii) is not registered—a person to whom a mark, plate, or permit has been issued to allow the vehicle to be used; and
- (b) a person who, according to the vehicle registration authority's records, has acquired the vehicle from the person in whose name the vehicle is registered under the relevant law; and
- (c) a person who is entitled to the possession of the vehicle.

"semi-trailer" means a trailer that has:

- (a) one axle group or single axle towards the rear; and
- (b) a means of attachment to a prime mover that would result in some of the load being imposed on the prime mover.

"road" means:

- (a) an area that is open to or used by the public and is developed for, or has as one of its uses, the driving or riding of motor vehicles; and
- (b) includes "highway" as defined in the Road Safety Act 1986.

"road train", means a combination of vehicles, other than a B-double, consisting of a motor vehicle towing at least two trailers (counting as one trailer a converter dolly supporting a semi-trailer).

Road authorities in all States and Territories are co-operating with the National Road Transport Commission and industry bodies to implement the Heavy Vehicle Reform Package. Its objective is to introduce national reforms for the road transport industry to deliver critical efficiency and safety benefits. The Victorian Government has announced the introduction of a package of reforms to the road transport industry. Part of the package includes initiatives to reduce fatigue related accidents involving heavy trucks and buses.

The objective to be achieved by the regulations is to improve safety management by employers\drivers of commercial trucks and commercial buses, with a view to reducing fatigue related accidents.

The proposed regulations:

- Prescribe periods of driving and nondriving for solo and two-up drivers of commercial trucks and commercial buses.
- Provide flexibility in the form of recording driving hours e.g. log book, automatic recording device or, for buses, a form issued by an employer.
- * Extend the operational radius to 100 km from the place of business from which the vehicle usually operates without the need to complete a log book.
- * Allow for approved fatigue management programs as a step towards management of fatigue through addressing a broad range of factors which contribute to fatigue related accidents.

The RIS examined a self-regulation regime through a Code of Practice as an alternative to the proposed regulations. Due to the voluntary nature of codes of practice, this alternative was considered to have the potential to reduce the current level of road safety and to significantly increase the risk to all road users.

The proposed regulations demonstrate that whilst there are some associated financial costs for the road transport industry, these are outweighed by the benefits provided to users of passenger services, other road users, and truck and bus employer/drivers in the form of improved road safety, uniformity between jurisdictions and innovative fatigue management programs.





- 1. This Order comes into operation on the date it is published in the Government Gazette.


