NOTICE OF DECISION

Proposed Wildlife (Game) (Human Safety) Regulations 1996

I, Charles Geoffrey Coleman, Minister for Natural Resources and Minister responsible for administering the Wildlife Act 1975, give notice under section 12 of the Subordinate Legislation Act 1994, as follows—

A regulatory impact statement (RIS) was prepared in relation to the proposed Regulations and advertised inviting public comment and submissions. Seventeen submissions were received commenting on various issues relating to the proposed Regulations and in particular, regulations 41, 42 and 44. After considering these comments, I have decided that the proposed Wildlife (Game) (Human Safety) Regulations 1996, be made without amendment.
