Subordinate Legislation Act 1994 NOTICE OF DECISION – PROPOSED VETERINARY SURGEONS (FEES) REGULATIONS 1996

Melbourne Cricket Ground Act 1984 MELBOURNE CRICKET GROUND (OPERATION OF FLOODLIGHTS) (AMENDMENT) ORDER No.3/1996

Title

1. This Order may be cited as the Melbourne Cricket Ground (Operation of Floodlights) (Amendment) Order No.3/1996.

Objective

2. The objective of this Order is to amend the *Melbourne Cricket Ground (Operation of Floodlights) Order No.1/1995 to allow the

operation of floodlights for the playing of a cricket match after 8pm on 12 November 1996.

Authorising provision

3. This Order is made under section 3 of the Melbourne Cricket Ground Act 1994.

Amendment to clause 4(b)

4. In clause 4(b) of the *Melbourne Cricket Ground (Operation of Floodlights) Order No.1/1995, after "1, 2, 3 and 4 April 1996; and" insert—

"12 November 1996;".
