Notice of Amendment Amendment L30

The amendment has been prepared by the Moreland City Council at the request of the owner who intends to develop the land for residential purposes.

The amendment affects land known as 72 Ross Street, Coburg (Lot 14 Block Plan B PS 7380, Vol 8841 Fol 515).

The amendment proposes to rezone the above land from the Light Industrial Zone to the Residential C Zone consistent with the zoning of land immediately surrounding the subject site to the north in Ross Street, the west side of Ross Street and in streets near by such as Ryan and Armstrong Streets.

FISHERIES (ROCK LOBSTER—OPEN SEASON) NOTICE No. 12/1996

1. Title

This Notice may be cited as the Fisheries (Rock Lobster—Open Season) Notice No. 12/1996.

2. Commencement

This Notice commences on 14 November 1996.

3. Objective

The objective of this Notice is to allow holders of crayfish licences to set crayfish pots up to 12 hours prior to the commencement of the open season for rock lobster, to facilitate an orderly and safe start to the open season.

4. Authorising Provision

This Notice is made under section 80 of the Fisheries Act 1968.

5. Amendment of Close Season Provisions

Despite anything to the contrary in regulation 9 (3) (b) of the *Fishing (Crayfish) Regulations 1989, a person operating a registered fishing boat licensed to take crayfish for sale, may leave or have a crayfish pot or crayfish coff immersed or set in any Victorian waters between the hours of 12.00 noon and 12.00 midnight on 15 November 1996.

6. Restriction on Leaving Wharf, Jetty or Pier

A person operating a registered fishing boat licensed to take crayfish for sale, must not leave the wharf, pier or jetty with a crayfish pot or crayfish coff on board the boat between the hours of 12.00 midnight on 14 November 1996 and 12.00 midnight on 15 November 1996.

7. Penalty

Any person who contravenes this Notice is liable to a penalty of 20 penalty units.
