Water Act 1989

I Charles, Geoffrey Coleman, Minister for Natural Resources, make the following Order:

AMENDMENT TO THE MEMBERSHIP OF THE CENTRAL HIGHLANDS REGION WATER AUTHORITY ORDER 1996

Citation

1. This Order is called the Amendment to the membership of the Central Highlands Region Water Authority Order 1996.

Empowering provisions

2. This Order is made under the powers conferred by Division 2 of Part 6 of the Water Act 1989 and all other enabling powers.

Date of effect

3. This Order takes effect on 7 March 1996.

Interpretation

4. In this Order—

“Previous Order” means the Change to the Name and Membership of the Ballarat Water Board Order 1994 published in the Government Gazette on 27 January 1994.

Change to membership

5. On and from the date on which this Order takes effect the previous Order is amended by substituting “nine members” for “seven members” in paragraph 5 (3) of the Previous Order.

Prerequisites for making this Order

6. This is an Order referred to in Section 99 (8) of the Water Act 1989.

Water Act 1989

I, Charles Geoffrey Coleman, as Minister administering the Water Act 1989, make the following Order:

CHANGE TO THE MEMBERSHIP OF THE SOUTH WEST WATER AUTHORITY ORDER 1996

Citation

1. This Order is called the Change to the Membership of the South West Water Authority Order 1996.

Enabling Powers

2. This Order is made under the powers conferred by Division 2 of Part 6 of the Water Act 1989 and all other available powers.

Date of Effect

3. This Order takes effect on 16 March 1996.

Definitions

4. In this Order:

“Act” means the Water Act 1989.

“The Authority” means the South West Water Authority formerly the Hopkins Region Water Authority which had its name changed to the South West Water Authority by an Order published in the Government Gazette No. S 1 of 12 January 1995.

“The Constitution Order” means the Constitution of the Hopkins Region Water Authority Order 1994 published in the Government Gazette No. S 40 of 29 June 1994.

Change to the Membership

5. On and from the date on which this Order takes effect:

Notwithstanding anything to the contrary in the Constitution Order the membership of the Authority is seven members appointed by the Minister in writing.

Pre-requisites for Making this Order

6. This is an Order referred to in Section 99 (8) of the Act.
