# Victoria Grants Commission Act 1976 APPOINTMENT OF THE CHAIRPERSON OF THE VICTORIA GRANTS COMMISSION

The Governor in Council acting under sections 3 and 6 of the Victoria Grants Commission Act 1976:

- Appoints Mr John Lester as the Chairperson of the Victoria Grants Commission for the period commencing on the day this appointment Order is published in the Government Gazette and ending on 16 January 1999 (inclusive) on a part time basis involving up to but no more than three days employment per week; and
- 2. Determines that Mr Lester's remuneration shall be based on a pro-rata equivalent of an annual remuneration of \$103, 607 per annum and that he shall also be entitled to be reimbursed for any travelling or other expenses reasonably incurred in the discharge of his duties as Chairperson.

Road Safety (Vehicles) Regulations 1988 EXTENSION OF PERIOD OF VALIDITY FOR THE GENERAL PERMIT FOR OVER HEIGHT VEHICLES CONSTRUCTED FOR THE TRANSPORT OF LIVESTOCK

Regulation 724 of the Road Safety (Vehicles)
Regulations 1988 authorises the Roads
Corporation, by notice in the Victoria
Government Gazette, to allow vehicles and
loads which exceed mass or dimension limits
prescribed in the Regulations to be used on
highways.

In accordance with that Regulation, I, Tony Fry, delegate of the Roads Corporation, extends the period of validity of the notice GENERAL PERMIT FOR OVER HEIGHT VEHICLES CONSTRUCTED FOR THE TRANSPORT OF LIVESTOCK which as published in the Victoria Government Gazette G 50 on 23 December 1992 from 1 January 1996 to 31 March 1996.

The amendments apply the "Special Use—Brown Coal Areas" Zone, introduced by Amendment S53, to most of the Business Areas of the electricity generation businesses. Private land remains within a reservation.

Two areas next to the Morwell urban area are rezoned to the Industrial 1 Zone (State section). These contain land which can be used for a range of industries and associated uses not necessarily connected with brown coal and electricity generation industries.
