Wildlife (Closure of Areas to Hunting) Notice No. 1 1996

I, Charles Geoffrey Coleman, Minister for Natural Resources, make the following Notice:

Wildlife (Closure of Areas to Hunting) Notice No. 1 1996

Title

1. This Notice may be cited as the Wildlife (Closure of Areas to Hunting) Notice No. 1 1996.

Objective

2. The objective of this Notice is to prohibit absolutely the taking, destroying or hunting of any particular kind or species of wildlife in certain parts of Victoria during the period commencing on Saturday, 16 March 1996 and ending on Monday, 10 June 1996 (both dates inclusive).

Authorising Provision

3. This notice is made under section 86 (1) of the Wildlife Act 1975.

Hunting of wildlife prohibited

4. The taking, destroying or hunting of any particular kind or species of wildlife is prohibited absolutely in the areas described in Schedules 1, 2, 3 or 4 below during the period commencing on Saturday, 16 March 1996 and ending on Monday, 10 June 1996 (both dates inclusive).

Penalty

5. Any person who contravenes this Notice is guilty of an offence and liable to a penalty not exceeding 25 penalty units.

SCHEDULE 1

The area within 500 metres of the Wool Wool Rocks being the rocks near the shore of that part of Lake Corangamite, in the Shire of Colac-Otway.

SCHEDULE 2

Lake Wandella (Brandy Lake), 5 Kilometres west of Kerang on Quambatook Road in the Parish of Meran.

SCHEDULE 3

Lake Elingamite, south of the township of Elingamite North in the Parish of Elingamite.

SCHEDULE 4

That part of Lake Connewarre and adjoining land shown by heavy border on the plan hereunder.
