Subordinate Legislation Act 1994
NOTICE OF PREPARATION OF
REGULATORY IMPACT STATEMENT
Alpine Resorts (General) Regulations 1996

Notice is given under section 11 of the **Subordinate Legislation Act 1994**, that a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Alpine Resorts (General) Regulations 1996.

The objectives to be achieved by the proposed Regulations are—

- (a) to provide the necessary tools for the effective management of Victoria's alpine resorts by the Alpine Resorts Commission; and
- (b) to provide an apparatus for the necessary revenue raising and entry conditions allowed under the **Alpine Resorts Act 1983**.

The reason for the proposed Regulations is that 3 sets of existing Regulations relating to the management of Alpine Resorts are due to expire in June 1996. Those Regulations have been reviewed and consolidated into one set to provide for the management and control of alpine resorts and to prescribe certain matters required under the **Alpine Resorts Act 1983**.

The RIS examined voluntary codes of conduct and the delegation of behavioural management responsibility as alternatives to the proposed Regulations covering general behaviour in, and use of, alpine resorts. Possible alternatives to the vehicle gate entry charges and other fees prescribed by the proposed Regulations, were no gate entry fees, different fee levels or charges based on the number of occupants of each vehicle. The RIS concluded that the proposed Regulations will make a positive contribution to the economic output of alpine resorts and that, overall, the alternatives considered would not provide better outcomes than the Regulations.
