Health Services Act 1988 **THE APPOINTMENT OF DIRECTORS TO** **THE BOARD OF THE INNER HEALTH** **CARE NETWORK**

The Governor in Council, on recommendation of the Minister for Health, by this Order—

1. Under section 40E (1) of the **Health Services Act 1988** appoints Graeme Samuel, Joanne Wilkinson and John King to the board of the Inner Health Care Network.

2. Specifies pursuant to section 40F (1) of the **Health Services Act 1988** that the term of each respective appointment is until 30 June 1996.

3. Orders pursuant to section 40F (2) (b) of the **Health Services Act 1988** that the rate of remuneration for each appointee shall be determined by the Minister and in accordance with Cabinet approved Guidelines.

4. Directs that this Order is to take effect from 21 May 1996.

Health Services Act 1988 **THE APPOINTMENT OF DIRECTORS TO** **THE BOARD OF THE EASTERN HEALTH** **CARE NETWORK**

The Governor in Council, on the recommendation of the Minister for Health under section 40E (1) of the **Health Services Act 1988**, by this Order—

1. Appoints Ben Lichtenberg, Kevin Courtney, Peter Morgan and Graeme Ryan to the board of the Eastern Health Care Network.

2. Specifies pursuant to section 40F (1) of the **Health Services Act 1988** that the term of each respective appointment is until 30 June 1996.

3. Orders pursuant to section 40F (2) (b) of the **Health Services Act 1988** that the rate of

remuneration for each appointee shall be determined by the Minister and in accordance with Cabinet approved Guidelines.

4. Directs that this Order is to take effect from 21 May 1996.

Health Services Act 1988 **AGGREGATION OF THE EASTERN** **HEALTH CARE NETWORK AND THE** **INNER HEALTH CARE NETWORK TO BE** **KNOWN AS INNER AND EASTERN** **HEALTH CARE NETWORK**

The Governor in Council, on the recommendation of the Minister for Health under section 65C of the **Health Services Act 1988**, by this Order—

1. Directs that under section 65C of the **Health Services Act 1988** the Eastern Health Care Network and the Inner Health Care Network be aggregated.

2. Pursuant to section 65C (4) (a) and (b) specifies 1 July 1996 as the date that—

(a) the incorporation of the Eastern Health Care Network and the Inner Health Care Network shall be cancelled; and

(b) a new hospital to be known as Inner and Eastern Health Care Network shall come into existence as if on that date it had been incorporated under the **Health Services Act 1988**.

3. Amends Schedule 3 of the **Health Services Act 1988** pursuant to section 65C (4) (c) with effect from 1 July 1996 by:

(a) adding the name Inner and Eastern Health Care Network; and

(b) removing the names of the Eastern Health Care Network and Inner Health Care Network.

4. Orders pursuant to section 65C (5) of the **Health Services Act 1988** that:

- (a) the initial Board of Directors of the Inner and Eastern Health Care Network will be constituted with effect from 1 July 1996 comprising the following members for the period of office as specified—

- (b) the rate of remuneration for the Chairperson and directors of the Inner and Eastern Health Care Network shall be determined by the Minister and in accordance with Cabinet approved Guidelines.

5. Orders pursuant to sections 65C (6) and 65C (9) that the by-laws of the Inner and Eastern Health Care Network are the by-laws approved by the Secretary to the Department of Human Services on 20 May 1996 and attached as attachment 1 and as altered by the Board of the Inner and Eastern Health Care Network from time to time in accordance with the **Health Services Act 1988**.

6. Orders pursuant to section 65C (9) of the **Health Services Act 1988** that Graeme Samuel is appointed as the first Chairperson of the Inner and Eastern Health Care Network.
