The amount of \$2,000,00 should read \$2,000,000.

NOTICE TO PUBLIC BODIES

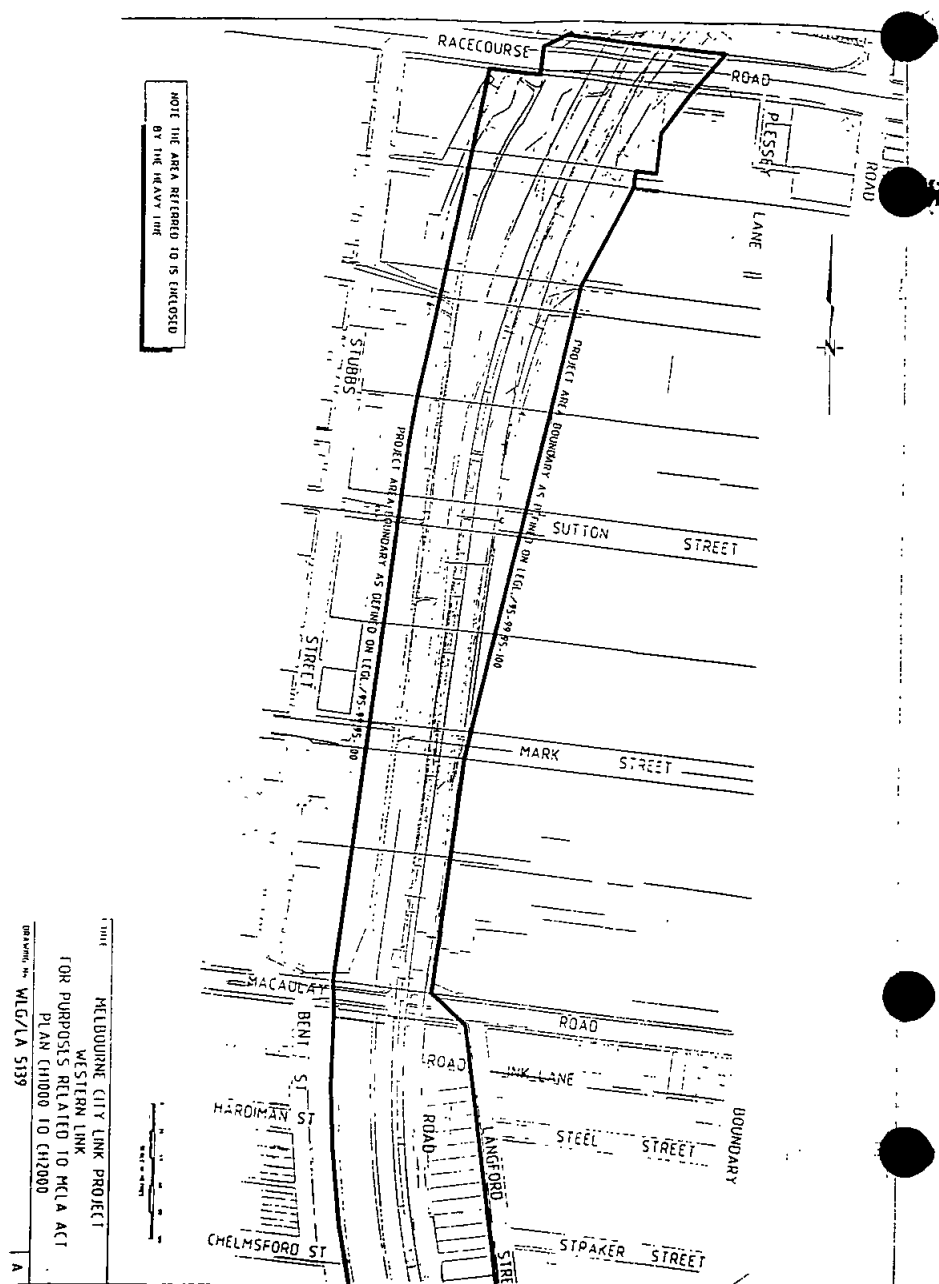

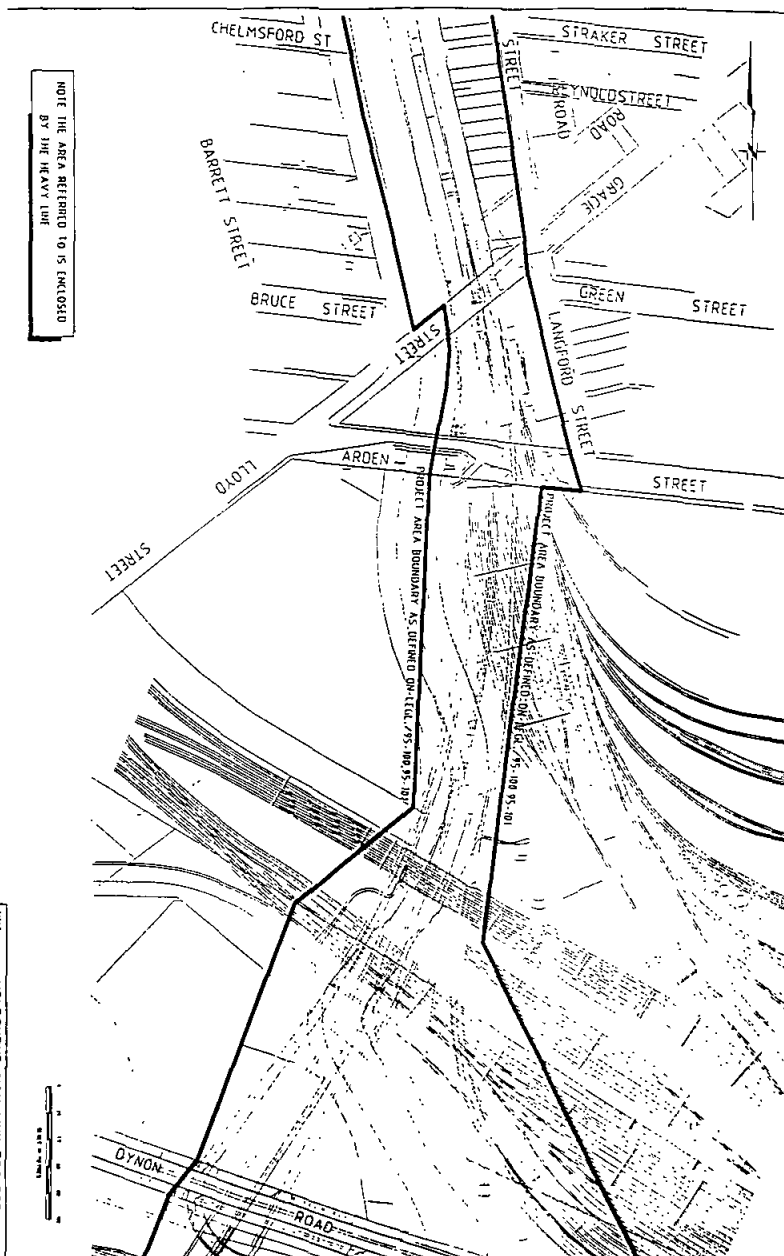

Responses should be forwarded to the Melbourne City Link Authority at Level 1, 150 Jolimont Road, East Melbourne 3002

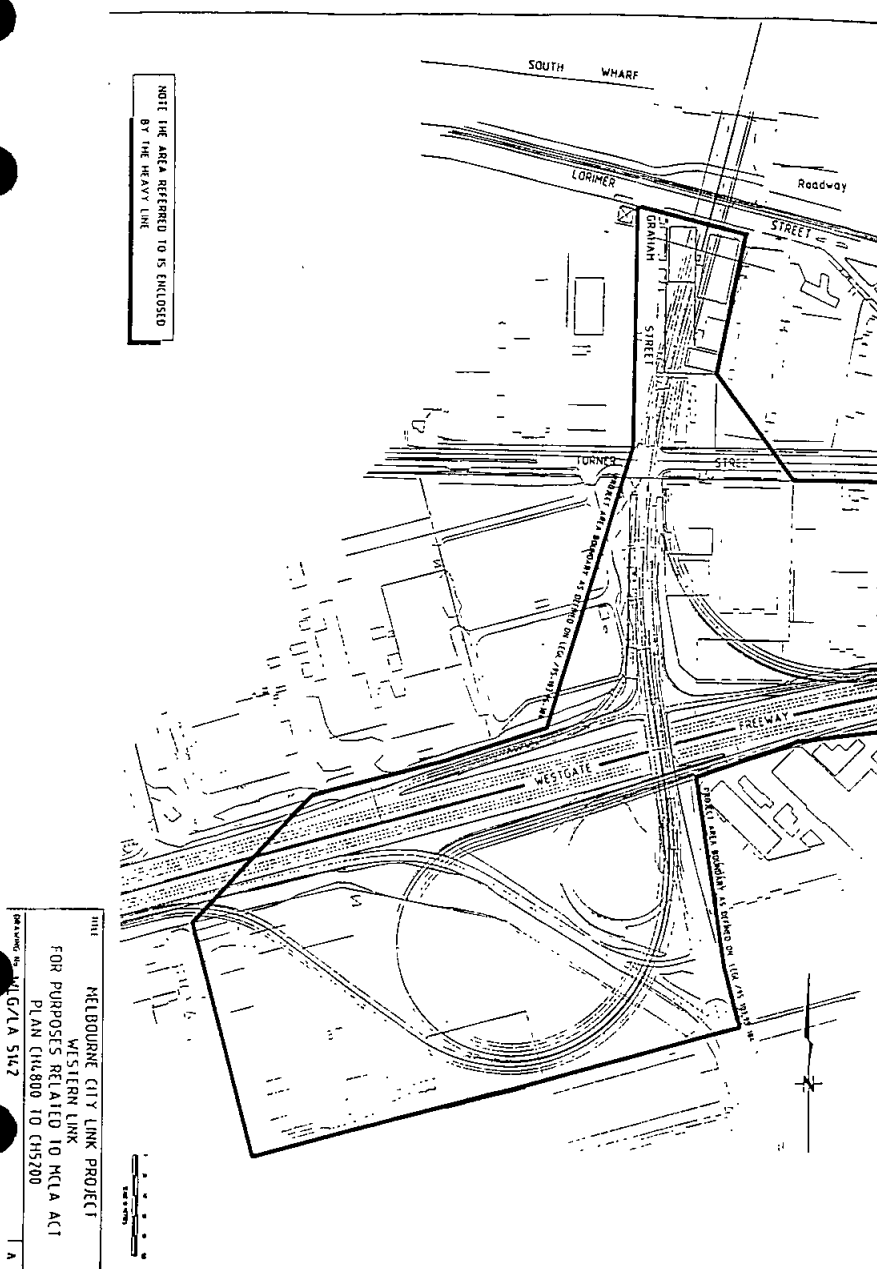

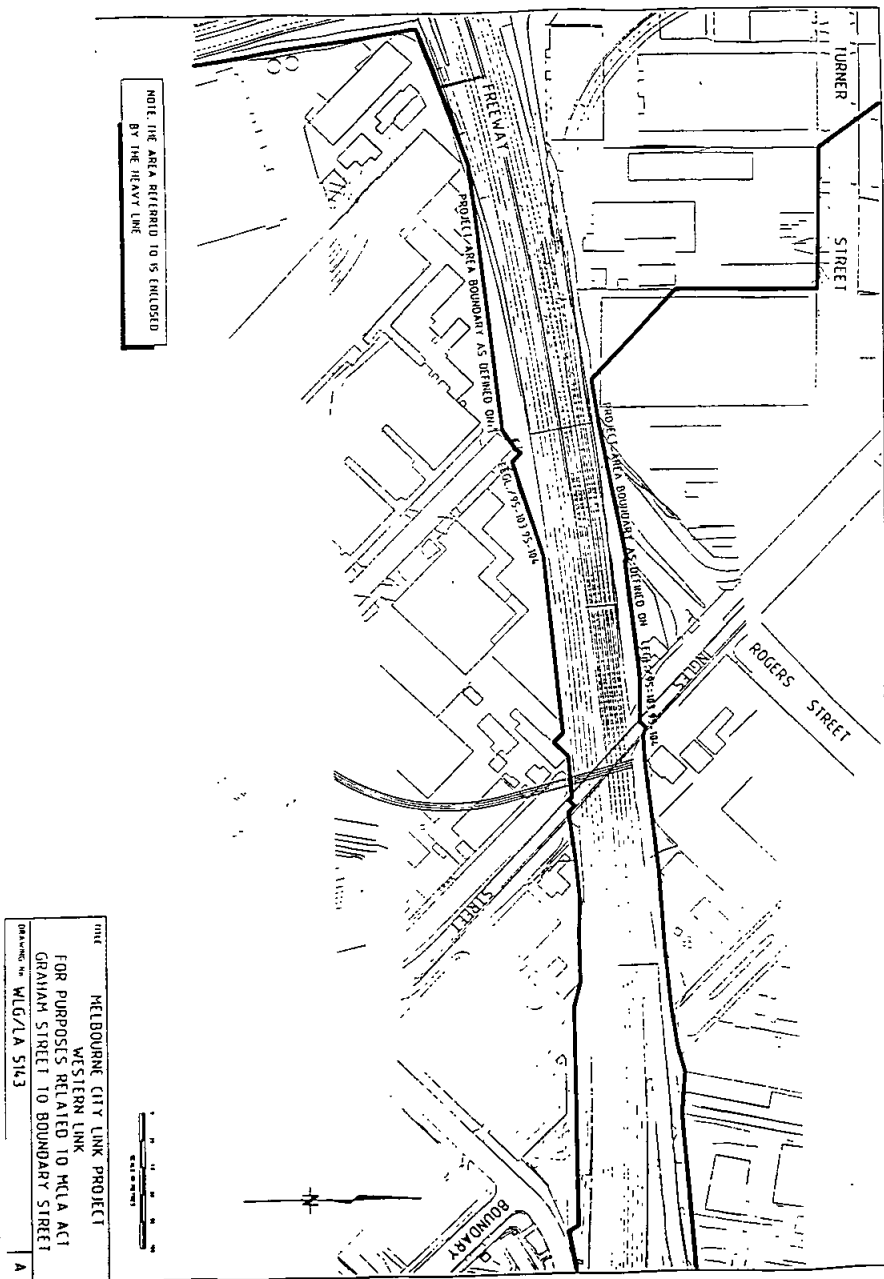
The land shown enclosed by the heavy line on the following six (6) plans:

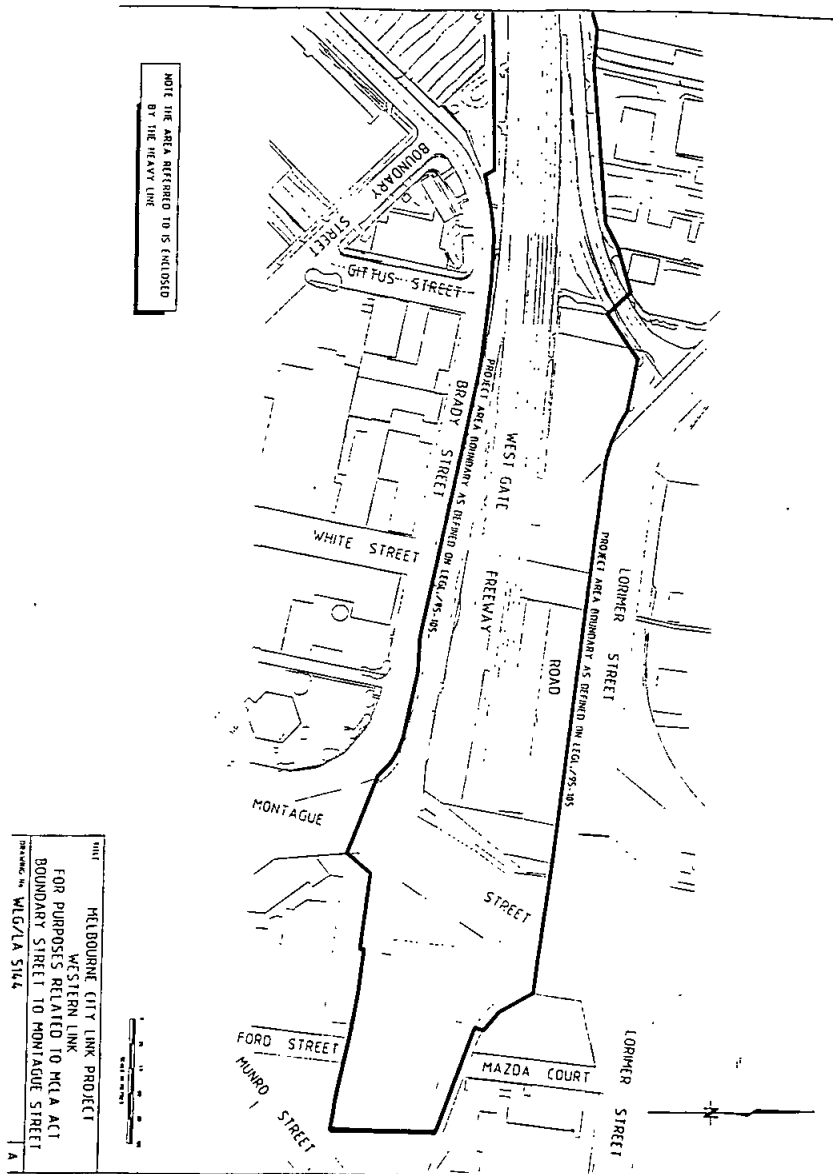
