Melbourne Cricket Ground Act 1984 MELBOURNE CRICKET GROUND (OPERATION OF FLOODLIGHTS) (AMENDMENT) ORDER No. 1/1996

I, Mark Alexander Birrell, Minister for Conservation and Environment, make the following Order:

Title

1. This Order may be cited as the Melbourne Cricket Ground (Operation of Floodlights) (Amendment) Order No. 1/1996.

Objectives

- 2. The objectives of this Order are to amend the Melbourne Cricket Ground (Operation of Floodlights) Order No. 1/1995 by:
 - (a) amending the purposes for which the floodlights may be operated; and
 - (b) adding two further days on which floodlights may be operated.

Authorising provision

3. This Order is made under section 3 of the Melbourne Cricket Ground Act 1984.

Amendment of purposes

4. In clause 4 (b) of the Melbourne Cricket Ground (Operation of Floodlights) Order No. 1/1995, delete "for the purpose of playing cricket", and substitute "for the purposes of playing cricket or conducting a practice session".

Amendment of days

5. In clause 4 (b) of the Melbourne Cricket Ground (Operation of Floodlights) Order No. 1/1995 insert after "2 February 1996".

Therapeutic Goods (Victoria) Act 1994

- I, Marie Tehan, Minister for Health, acting under section 9 of the **Therapeutic Goods** (Victoria) Act 1994 exempt from the operation of:
- (1) sections 16 and 17 of the Act, the following therapeutic goods—

Tampons, subject to the following conditions:

- (a) the goods are supplied in the original unopened pack as supplied by the manufacturer; and
- (b) the goods are included in the Australian Register of Therapeutic Goods.

Sunscreens (having a Sun Protection Factor (SPF) exceeding 4,) subject to the following conditions:

- (a) the goods are supplied in the original unopened pack as supplied by the manufacturer;
- (b) the goods are included in the Australian Register of Therapeutic Goods; and
- (c) in the case of supply by vending machines, the machine is located in a place where the temperature conditions do not compromise the integrity of the goods; or
- (d) in the case of the goods being supplied from house to house or in a street, the goods are stored in a manner that does not compromise the integrity of the goods.

Hypodermic needles and syringes when supplied by a person under section 80 (5) of the Drugs, Poisons and Controlled Substances Act 1981.

Condoms and lubricants, subject to the following conditions:

 (a) the goods are supplied in the original unopened pack as supplied by the manufacturer;

- (b) the goods are included in the Australian Register of Therapeutic Goods; and
- (c) in the case of supply by vending machine, the machine is located in a place where the temperature conditions do not compromise the integrity of the goods; or
- (d) in the case of the goods being supplied from house to house or in a street, the goods are stored in a manner that does not compromise the integrity of the goods.
- (2) section 16 of the Act-

Water for Injections, subject to the following conditions:

- (a) the goods are supplied in their original unopened pack as supplied by the manufacturer; and
- (b) the goods are included in the Australian Register of Therapeutic Goods.
- (3) sections 12, 15 and 16 of the Act-

Water for Injections when supplied in other than the original pack as supplied by the manufacturer, subject to the following conditions:

- (a) the goods are supplied by a person under section 80 (5) of the Drugs, Poisons and Controlled Substances Act 1981; and
- (b) the goods are withdrawn from a primary pack of ampoules of Water for Injections that are included in the Australian Register of Therapeutic Goods.
- (4) sections 12 and 16 of the Act-

Condoms when supplied in other than the original pack as supplied by the manufacturer, subject to the following conditions:

- (a) the goods are supplied in their immediate wrappers from a primary pack of condoms that are included in the Australian Register of Therapeutic Goods:
- (b) the goods are distributed by a person under section 80 (5) of the Drugs, Poisons and Controlled Substances Act 1981;

- (c) the person to whom the goods are supplied is given written information about the use of the goods; and
- (d) the goods are stored in a manner that does not compromise the integrity of the goods.
