Melbourne City Link Act 1995 REVOCATION OF PART OF RESERVATION

The Governor in Council, on the recommendation of the Minister for Planning and Local Government (being the Minister administering the **Melbourne City Link Act 1995**), under section 29(2) of the **Melbourne City Link Act 1995** revokes:

the Order in Council of 12 January 1932 (vide Government Gazette 20 January 1932, p.144) temporarily reserving land at Melbourne (Royal Park) as a Site for Hospital for Acute Mental Diseases in so far as the Order relates to the land shown hatched on plan numbered LEGL/96-412 lodged in the Central Plan Office.
