- \* Public Health Local Law No. 1
- \* Roads and Traffic Local Law No. 2
- \* Management of Council Property Local Law No. 3
- \* Foreshore Reserves Local Law No. 4

The purpose and general purport of the respective local laws are as follows:

**Local Law No. 1—Public Health**

The objectives of this local law are to:

- (a) provide for the peace, order and good government of the municipal district
- (b) provide for the administration of council powers and functions
- (c) promote a physical and social environment free of hazards to health
- (d) prevent and remedy nuisances or conditions liable to be dangerous to health or offensive to people

- (e) to repeal local laws of the former municipalities to the extent that any provisions contained in them are inconsistent with the provisions of this local law

The Local Law is divided into parts and the general purport of each part is summarised as follows:

Part 1 Preliminary Provisions, including title, objectives, definitions, applications and general information

Part 2 The regulation and control of refuse, recyclable material, use of land fill sites and dumping of ice chests and similar containers

Part 3 The regulation and control of septic tanks and temporary toilet facilities on building sites

Part 4 The regulation and control of drains on private property

Part 5 Permit fees and delegations

Part 6 The regulation and control of asbestos removal

Part 7 Enforcement

**Local Law No. 2—Roads and Traffic**

The objectives of this local law are to:

- (a) provide for the peace order and good government of the municipal district
- (b) provide for the administration of council powers and functions
- (c) provide for the protection and safety of council roads and land
- (d) regulate the use of roads, council land and other places
- (e) regulate the use of various types of vehicles and animals and behaviour relating to them for the safety and convenience of road users
- (f) regulate secondary activities on roads including trading, placing of goods and equipment, repairs to vehicles, parties, festivals and processions, advertising and collections
- (g) complement the Road Safety (Traffic) Regulations 1988 particularly relating to car parking
- (h) prescribe procedures for the temporary or permanent closure of roads
- (i) repeal local laws of the former municipalities to the extent that any provision contained in them are inconsistent with this local law.

The Local Law is divided into parts and the general purport of each part is summarised as follows:

Part 1 Preliminary Provisions, including title, objectives, definitions, applications and general information

Part 2 The regulation and control of road opening, reinstatement and works and vehicle crossings

Part 3 The regulation and control of street parties, festivals and processions

Part 4 The regulation and control of dog and animal litter, shopping trolleys, moveable advertising signs, display of goods, outdoor eating facilities, trading on roads and in public places, street appeals and stalls, trading sites, obstructions, repairing vehicles, grazing animals, unregistered or unroadworthy vehicles, impounding of vehicles, heavy vehicles, restrictions on road use and toy vehicles and bicycles

Part 5 The regulation and control of resident parking scheme

Part 6 The regulation and control of the disabled persons parking scheme

Part 7 The regulation and control of fee and time limit parking

Part 8 Permits, fees and delegations

Part 9 Enforcement

#### Local Law No. 3—Management of Council Property

The Objectives of this Local Law are to:

- (a) provide for the peace order and good government of the municipal district
- (b) provide for the administration of council powers and functions
- (c) provide for the protection of council property
- (d) provide for orderly and equitable access to and management of council property
- (e) regulate behaviour in or on municipal buildings and reserves
- (f) repeal local laws of the former municipalities to the extent that any provisions contained in them are inconsistent with this local law.

The Local Law is divided into parts and the general purport of each part is summarised as follows:

Part 1 Preliminary provisions, including title, objectives, definitions, applications and general information

Part 2 The regulation and control of municipal buildings

Part 3 The regulation and control of public reserves and recreation lands including the control of dogs on such reserves and lands

Part 4 The regulation and control of lighting fires, interference with watercourses, drain tapping and damage caused by trees and plants

Part 5 Permit fees and delegations

Part 6 Enforcement

#### Local Law No. 4—Foreshore Reserves

The Objectives of this Local Law are to:

- (a) provide for the peace order and good government of the municipal district
- (b) allow and protect the quiet enjoyment by people of the foreshore reserves and the foreshore reserve extensions
- (c) provide for the administration of council powers and functions
- (d) control and prohibit behaviour in a reserve which is a nuisance, or which may be detrimental to health and safety or which affects the enjoyment of recreational and other facilities
- (e) provide for the protection of the foreshore reserves
- (f) provide for equitable access to and enjoyable use of the foreshore reserves in respect of the whole community and to regulate such access and use so that it does not in any case cause nuisance or unreasonable interference to others
- (g) regulate the use of the reserves by animals and vehicles.

The Local Law is divided into parts and the general purport of each part is summarised as follows:

Part 1 Preliminary Provisions, including title, objectives, definitions, applications and general information

Part 2 the regulation and control of the use and protection of the foreshore reserves including behaviour, camping, animals, fires, beach umbrellas, stranded vehicles, bathing boxes, boat houses and the control of dogs on such foreshore reserves

Part 3 Permit fees and delegations

Part 4 Enforcement

The local laws include specification of what form of regulations apply in order to achieve the stated objectives in each local law. They provide that certain activities may not be undertaken at all or without a permit (or exemption or licence), allowing for conditions and fees to apply to permits (or licences) and for conditions to apply to any exemptions. They allow for the issue of notices to comply in certain circumstances such as where conditions of a permit are not being met and provide for authorised officers to prosecute offences either by the issue of infringement notices or by Court procedure. The local laws set standards to be followed in exercising discretions and repeal a number of redundant local laws of former Councils.

The local laws apply to the whole of the municipal district except in those circumstances where provisions apply to a localised area (such as the Foreshore Reserve) and allow for designation of further areas by resolution of Council. The aim is for better regulation of activities within the municipal district and on the Foreshore Reserve with a view to consideration of the welfare of the whole community.

#### CHIROPRACTORS AND OSTEOPATHS REGISTRATION BOARD OF VICTORIA

Notice of Decision for Publication in  
Government Gazette

1. On 21 November 1995 the Chiropractors and Osteopaths Registration Board of Victoria ("Board") found as a result of an inquiry conducted pursuant to section 13A of the **Chiropractors and Osteopaths Act 1978** ("Act") that Dr Victor John Portelli was guilty of unprofessional conduct in that:

- (a) Dr Portelli did in or about the period November 1988 to May 1993 as a matter of general practice rely on results of physical examinations and other tests carried out by unqualified staff to determine appropriate treatment for patients without your conducting those procedures;
- (b) in or about March 1991 at the East Keilor Clinic Dr Portelli did encourage David Minter to direct, suffer or permit

- chiropractic assistants, who are not eligible for registration under s. 8 (2) of the Act to conduct x-ray reviews on patients and interpret x-rays for patients;
- (c) in or about mid 1991 at the East Keilor clinic, Dr Portelli did advise patients referred to him for a second opinion by David Minter, a chiropractor engaged to work in the East Keilor clinic under Dr Portelli's supervision and control, so as to mislead the patient to believe that they had a serious problem requiring long term chiropractic care without proper regard to the patient's condition;
  - (d) Dr Portelli did, in or about the period November 1988 to August 1992, in a weekly meeting at the East Keilor clinic, direct David Minter to routinely send new patients to Dr Portelli after the first 4-5 visits, and advise patients that Dr Portelli was a chiropractic specialist and that the referral was a second opinion, without proper regard for the patient's conditions;
  - (e) in or about 1 February 1991, at the Keilor Clinic Dr Portelli did direct, suffer or permit William Frederico to:
    - (i) conduct an x-ray review on a patient; and
    - (ii) interpret x-rays for the patient;
  - (f) in or about the period November 1988 to August 1992, at the East Keilor clinic Dr Portelli did direct, suffer or permit chiropractic assistants to:
    - (i) conduct x-ray reviews on patients; and
    - (ii) interpret x-rays for those patients;
  - (g) in or about 1 February 1991, at the Keilor clinic Dr Portelli did direct Elisabeth Kenny to:
    - (i) conduct an x-ray review for a patient; and
    - (ii) interpret x-rays for that patient;
  - (h) in or about February 1991, at the Keilor clinic, Dr Portelli did direct Elisabeth Kenny in interpreting x-rays to advise patients that a particular bone had changed shape, that the condition was serious, that the bone was degenerating, and that "we can reverse the process" or words to that effect, without proper regard for the patient's condition;
  - (i) in or about 1 February 1991, at the Keilor clinic, Dr Portelli did direct Elisabeth Kenny to exaggerate the seriousness of a patient's condition to the patient;
  - (j) in or about the period February 1991 to September 1992, in meetings and during work hours at the Altona clinic Dr Portelli did direct Elisabeth Kenny when examining patients, to exaggerate the finding of pain or weakness, to always state that long courses of treatment were required, to misrepresent to patients the seriousness of their condition and to encourage patients to undertake long term care, all without proper regard for the patient's condition;
  - (k) in or about the period 1 February 1991 to 25 September 1992 at spinal screenings conducted at Deer Park Shopping Centre, Highpoint West Shopping Centre or Altona Gate Shopping Centre Dr Portelli did encourage or invite Elisabeth Kenny to examine people participating in the spinal screenings and advise them that they had a serious condition requiring long term chiropractic care;
  - (l) in or about the period of 1 January 1991 to June 1992 at spinal screenings conducted at High Point Shopping Centre, Deer Park Shopping Centre, Werribee, Altona North, and Westfield Shopping Centre, Dr Portelli did direct, encourage or invite Phillip Prince to carry out examinations on people, feel their spine and tell them that they had a problem and that Dr Portelli was able to help;
  - (m) over the period November 1988 to August 1992, at spinal screenings conducted at Altona Gate Shopping centre, Westfield Shopping Centre, Airport West Shopping Centre, Werribee Plaza Shopping Centre, High Point City Shopping Complex, or Footscray, Dr Portelli did direct William Frederico and Phillip Prince to examine people participating in the spinal screenings and advise them that they had a problem which was caused by pressure on nerves and that this pressure would cause the nerves to die, and that you could fix their problem;



- (n) in or about the period of 19 January 1991 to 28 August 1992 at a weekly meeting in the East Keilor or Sunshine clinics, Dr Portelli did direct, encourage or invite William Frederico and Elisabeth Kenny when conducting muscle tests or x-ray reviews on patients to advise them:

- (i) that there was a problem with their neck or lower back and that Dr Portelli could "fix it" or words to that effect in all cases;
- (ii) that they "had a bone out of place" or words to that effect and that they should see Dr Portelli as Dr Portelli could "fix their problem" or words to that effect;

- (o) that over the period 28 July 1992 to May 1993 Dr Portelli did cause, permit or suffer to be conducted spinal screenings at:

- (i) Deer Park Shopping Centre;
- (ii) Highpoint Shopping Centre;
- (iii) Prahran Market.

2. As a result of the above findings the Board resolved on 11 December 1995 to:

- (a) suspend Dr Portelli's registration as a chiropractor and osteopath for a period of 12 months commencing on 1 March 1996;
- (b) impose on Dr Portelli a fine of \$500 in respect of each of 15 proven charges, being a total of \$7,500; and
- (c) impose in relation to Dr Portelli's practice as a chiropractor and osteopath the following condition:  
 "Dr Portelli is to permit and co-operate with any audit that the Board authorises on the conduct of his practice in all its aspects including:
  - \* patient management;
  - \* staff management and practice;
  - \* financial management; and
  - \* practice promotion and advertising."

The purpose and general purport of the Local Laws are:

#### LOCAL LAW 2—STREETS AND ROADS

- To provide for and control the management of traffic, use of roads by persons, and vehicles and animals and to regulate the parking of vehicles for the safety and fair use by people in the municipal district;

- to provide for the peace, order and well being of people in the municipal district,

- to provide for the physical features of the road and adjacent properties to be managed in a way which attends to the safety and convenience of people travelling on, or using the road (whether on foot or by vehicle);

- to control various types of vehicles and animals for the safety and convenience of road users;

- to preserve and protect as far as possible the Council's assets from damage which may be caused from extraordinary use of streets and roads within the municipal district;

- preventing the spread of disease in the municipal district; and

- protect council land and prohibit, regulate and control the discharge of water thereon.  
- to control and regulate secondary activities on roads including:

- (i) trading;
- (ii) the placing of goods and equipment;
- (iii) repairs to vehicles; and
- (iv) parties, festivals and processions

in a fair, equitable and safe manner which does not compromise the primary need for the passage and repassage of people and goods; and  
- to provide free and safe access for people with sight and movement impairment or disabilities; and

- to provide for the safe and efficient management and control of parking on roads in the municipal district

- to provide mechanisms to manage and control parking so as to cause minimal disruption, danger or nuisance to the users of Council's parking facilities.

#### LOCAL LAW NO. 3 THE ENVIRONMENT:

- To provide a safe and healthy environment in which the residents of the municipal district can enjoy a quality of life that meets the general expectations of the community; and

- to prohibit, regulate and control activities which may be dangerous or unsafe or detrimental to the quality of life in an environment of the municipal district; and

- to facilitate the provision of general public services, health and other community services, property services, recreational and cultural services and other services in a way which enhances the environment and quality of life in the municipal district; and

- to control nuisances and noise, odour and smoke emissions, and other discharges to the environment which may adversely affect the enjoyment of life within the municipal district or the health, safety and welfare of persons within the municipal district; and

- in a way which is consistent with, and in furtherance of, the objectives specified above to prohibit, regulate and control activities and circumstances associated with:

- (i) smoke emission, particularly emission from burning material and from chimneys; and
- (ii) the use of recreational vehicles which are not used on appropriate land or reserves; and

- (iii) dangerous and unsightly land; and
- (iv) advertising and bill posting; and
- (v) camping and temporary dwellings; and
- (vi) circuses, carnivals and festivals; and
- (vii) quarrying; and
- (viii) water quality, including interference with water courses; and
- (ix) animals, including animal numbers and the keeping and control of animals birds and insects; and
- (x) disposal of waste including behaviour associated with tips; and
- (xi) the prevention of fruit fly; and
- (xii) building site controls, satellite dishes, building works and noise and dilapidated buildings; and builders sanitary conveniences.

#### LOCAL LAW NO. 4—MUNICIPAL PLACES:

- To allow and protect the quiet enjoyment by people of municipal places within the municipal district; and

- to enable people in the municipal district to carry out their day to day activities and to enjoy their recreational pursuits without having their peace and enjoyment interfered with or destroyed; and

- to recognise and respond to community expectations relating to the quality of life they expect and require and are capable of influencing; and

- to control and prevent behaviour which is a nuisance, or which affects the enjoyment of recreational or other activities; and

- to enable the community and visitors and their families who use municipal places that are available to the public, to be confident in their choice of the use of those facilities or places; and

- to protect Council and community assets and facilities on or in municipal places; and

- in a way which is consistent with, and in furtherance of, the objectives specified in paragraphs (as listed above) to prohibit, regulate and control;

- (i) behaviour in municipal places which is boisterous or harmful or intimidating;
- (ii) behaviour in municipal places which is offensive dangerous or threatening or which, for other reasons, is inappropriate in a municipal place;
- (iii) the places and times at which alcohol may be consumed or possessed;

(iv) smoking in specified circumstances and places;

- to provide generally for the peace, order and good government of the municipal district; and

- to provide for the administration of the Council's powers and functions.

**REGULATIONS**  
Johnny Mullagh Memorial Park

*Title*

1. These Regulations may be cited as the Johnny Mullagh Memorial Park Regulations 1995.

*Objective*

2. The objective of those regulations is to provide for the care, protection and management of the Johnny Mullagh Memorial Park hereafter referred to as the "Park".

*Authorising Provisions*

3. These Regulations are made under section 13 of the **Crown Land (Reserves) Act 1978**.

*Commencement*

4. Those Regulations come into operation on the date they are published in the Victoria Government Gazette.

*Definitions*

5. In these Regulations—

"Act" means the **Crown Land (Reserves) Act 1978**.

"Appointed Officer" means any person appointed in writing by the Committee as an appointed officer for the purpose of these Regulations.

"Committee" means the Committee of Management appointed to manage the park under section 14 of the Act

"Litter" includes any bottle, carton, package, paper, glass, food, offal, animal carcass, vegetable matter or other refuse or rubbish.

"Permit" includes any authority, approval, consent, permission, receipt, ticket or the like given, granted or issued by the Committee under these Regulations.

"Vehicle" includes any motor car, motor cycle, bus, truck, bicycle, care, horse, drawn vehicle, caravan, trailer or water craft.

"Park" means Crown Allotments 11 & 12, Section 4, Township of Harrow, temporarily reserved by the Order in Council 15 May 1871 (vide Government Gazette dated 19 May 1871) for Recreation Purposes.

*Powers Functions and Duties of the Committee*

- 6 (1) The Committee may in either general or specific terms, determine when the Park shall be open to the public.
- (2) The Committee may enclose or set aside for a particular activity the whole or any part of the Park and may include in that determination conditions or restrictions relating to use by the Public of that area.
- (3) The Committee may determine the conditions of entry or use of any convenience, facilities or amenities or any description in any part of the Park.
- (4) The particulars of any determination made under regulation 6 (1), (2) and (3) must be displayed where they are reasonably likely to be seen by persons likely to be affected by them.

*Permits*

7. (1) The Committee or an appointed officer may at its discretion grant permits for:
  - (i) the admission and entry to the Park or any part thereof.
  - (ii) any other purpose for which a permit is required under these regulations.
- (2) The committee may determine the conditions of any permit granted under these Regulations.
- (3) The Committee may impose, collect and receive tolls, fees or other charges for or in respect to:
  - (i) the admission or entry to the Park.
  - (ii) any other permit granted pursuant to sub-regulation 7 (1).
- (4) Any person purporting to hold any permit must produce it on demand by an appointed officer and unless such permit is produced, that person shall not be entitled to claim the benefit of any such permit.

8. Any permit granted under these Regulations may be revoked or withdrawn at the discretion of the Committee or an appointed officer.

#### Offences

9. Within the Park a person must not:

- (a) enter or remain who, in the opinion of an Appointed Officer may offend against decency as regards dress, language or conduct;
- (b) place any advertisement, placard or notice upon any tree, structure or path without the consent of the Committee;
- (c) sell or offer for sale any article or solicit or gather money or hand out literature without the permission of the Committee;
- (d) interfere with any person lawfully using the Park;
- (e) interfere with or damage any building, structure or other property or any tree, shrub or plant;
- (f) leave or deposit any rubbish except in receptacles provided for the purpose;
- (g) light a fire except at such places as are set aside for the purpose by the Committee or any Appointed Officer and as such times as allowed by the Country Fire Authority.
- (h) carry or discharge any weapon without the written consent of an Appointed Officer;
- (i) snare or destroy any animal or bird without the consent of an Appointed Officer;
- (j) occupy any building for any private or public activity without the written permission of the Committee;
- (k) camp or erect any structure without the permission of the Committee or an Appointed Officer;
- (l) remain when lawfully directed to leave an Appointed Officer or an employee of the Committee;
- (m) bring into or permit to remain any dog, which is not controlled by means of a leash or other form of restraint;

10. The owner of any animals found wandering in the Park, except with permission of the Committee, shall be guilty of an offence against the Regulations.

11. (i) No motor car or other vehicle shall be taken onto the Park except:

- (a) with the permission of the Committee or an Appointed Officer; or
- (b) for the purpose of using an area specially set aside by the Committee as a car park.

(ii) The use of any car park shall be subject to such conditions and arrangements as the Committee may determine.

12. No alterations, additions or other works shall be undertaken on the Park or any structure thereon without the written approval of the Committee.

13. An Appointed Officer or employee of the committee may direct a person who in their opinion offends against any of these Regulations to leave the Park or place therein.

14. These Regulations shall not restrict any servants, agents or workmen of the Committee in the proper execution of their duty or work in the Park.

15. Any person who contravenes or fails to comply with these Regulations shall be liable to the penalties prescribed in section 13 of the **Crown Land (Reserves) Act 1978**.—Rs1733

Council Meetings Procedures

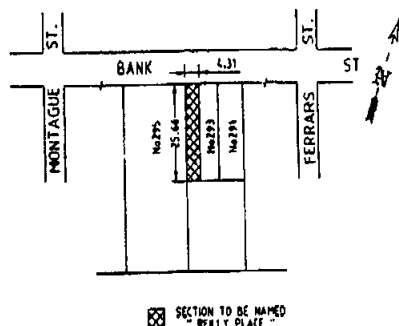

And whereas clause L9.5 addressed the means by which the Council could designate any area or areas and any times and dates during which such restriction are to be in place, the Council now amends that local law in respect of the powers under the above objectives by inseting definitions of Albert Park, Grand Prix and Race Period adding a sub-clause to clause L9.5 which will prohibit the consuming of alcoholic beverage or the possession of alcoholic beverage in an unsealed container in a public place in the municipal district (other than in any licensed premises or in any extension of licensed premises permitted by the Liquor Licensing Commission and or the Council) during the eight day period being the race period of the Grand Prix and the day after the holding of the Grand Prix in any year without the need for the area of the municipal district to be specifically signposted as to the nature of the restriction.

The general purport of the amendment is to create the above prohibition during the time mentioned and to constitute an offence for acting contrary to such prohibition which may be prosecuted in Court or by issue of an infringement notice.

The aim of the amendment is to more appropriately regulate behaviour in the municipal district during the expected influx of people for the Grand Prix with a view to consideration of the welfare of the whole community.

Notice of Provision in a local law regulating the use, possession or consumption of alcohol (for purposes of Police acting as authorised officers under Section 224A of the **Local Government Act 1989**)

Whereas the Port Phillip City Council made a local law entitled Port Phillip City Council Streets Roads and Other Public Places Local Law No. 4 on 4 July 1995 and subsequently amended that local law on 5 December, 1995, notice is hereby given of the following provisions within that amended local law which may be enforced by any police officer:

**L9.5 Restrictions Relating to Alcoholic Beverages**

(1) The Council may from time to time designate any area or areas within the municipal district into which alcoholic beverages may not be taken and the times and dates during which such restrictions are to be in place.

(2) The Council may from time to time designate any area or area within the municipal district within which a person may not consume any alcoholic beverage or have in his or her possession any alcoholic beverage in an unsealed container and the times and dates during which such restrictions are to be in place.

(3) Any designation of areas, times and dates under sub-clause (1) or (2) must be published by the Council by:

- (a) giving public notice at least 14 days before the restrictions are to be introduced;
- (b) giving notice in a newspaper generally circulating throughout Victoria of the restrictions to be introduced;
- (c) posting notices on a publicly accessible notice board at the principal office of the Council; and
- (d) retaining a copy of the public notice in the register of determinations to be kept with this local law from the date of the notice until the restrictions have ceased to operate.—L.22

(4) The Council must cause any designated areas to be signposted with sufficient signs to indicate to any person entering the area designated under sub-clause (1) or (2) the nature of any such restriction and the times and dates during which such restrictions are in place.

(5) A person without a permit must not take any alcoholic beverage onto an area designated under sub clause (1) during the time and on the dates during which restrictions are in place.

Penalty: 2 penalty units

(6) A person must not have in his or her possession or under his or her control any unsealed container of alcoholic beverage or consume any alcoholic beverage in an area designated under sub-clause (2) during the time and dates during which restrictions are in place.

Penalty: 2 penalty units

(7) In considering the granting of any permit under sub-clause (5), the Council must have regard to the Standards in Part 12 and any guidelines determined by Council from time to time.—S17

“(8) Notwithstanding the other provisions of this Clause:

- (a) a person may not in a public place in the municipal district consume any alcoholic beverage or have in his or her possession any alcoholic beverage in an unsealed container in the race period or in the day following the race period in any year.

Penalty: 2 Penalty Units

- (b) The provisions of paragraph (a) do not apply to the consumption of any alcoholic beverage or the having in possession of any unsealed container of alcoholic beverage:

- (i) In any licensed premises or in any extension of licensed premises permitted by the Liquor Licensing Commission and/or the Council or any other permitted premises; or

- (ii) to the extent that it might be inconsistent with any provision under the **Australian Grand Prix Act 1994**, in Albert Park in the race period;

- (c) for the duration of the race period and the day following, a person contravenes paragraph (a) regardless of whether or not the area in which the consumption or possession takes place is signposted in accordance with sub-clause (4).

The local law includes the following definitions which are relevant to the interpretation of clause L9.5 (8):

"Albert Park": means that part of the land, referred to by that name in the **Australian Grand Prix Act 1994**, which the Grand Prix Corporation fences or cordons off under Section 32 (1) of that Act for the race period in any year.

"Grand Prix": means the annual Formula One Grand Prix at Albert Park.

"Race Period": has the same meaning as in the **Australian Grand Prix Act 1994**.

It also provides for the issue of an infringement notice as an alternative to prosecution in the court. The penalty for infringement notice purposes in respect of non compliance with any provision in clause L9.5 is 1 penalty unit (\$100).

Part 4 To regulate street selling, collections, distributions and entertainment.

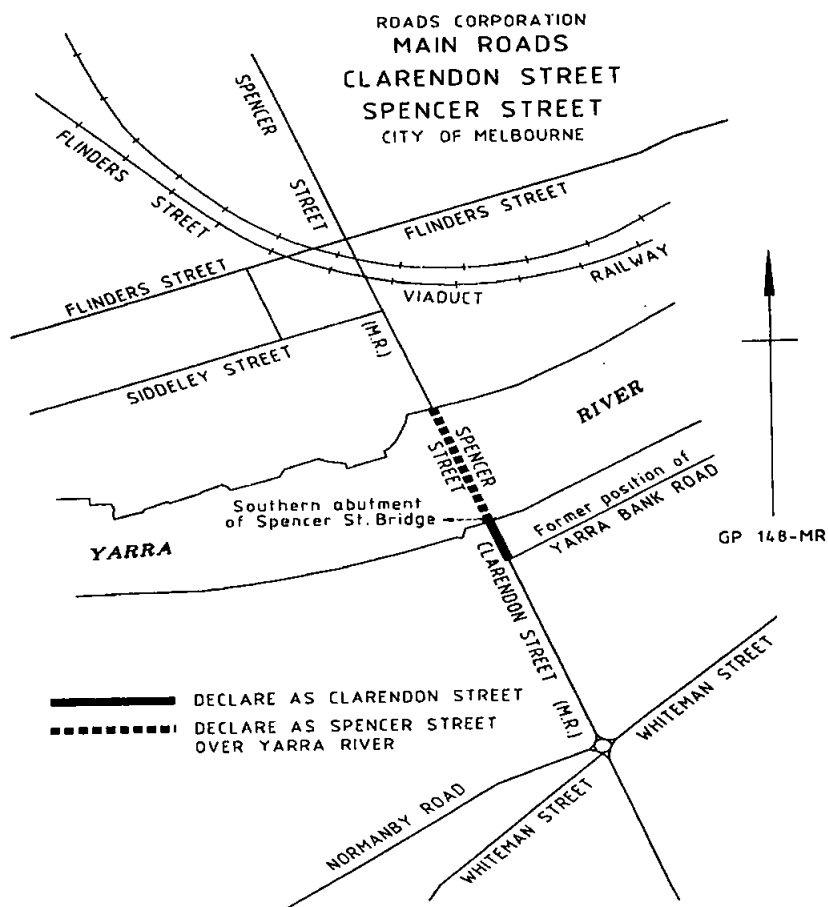

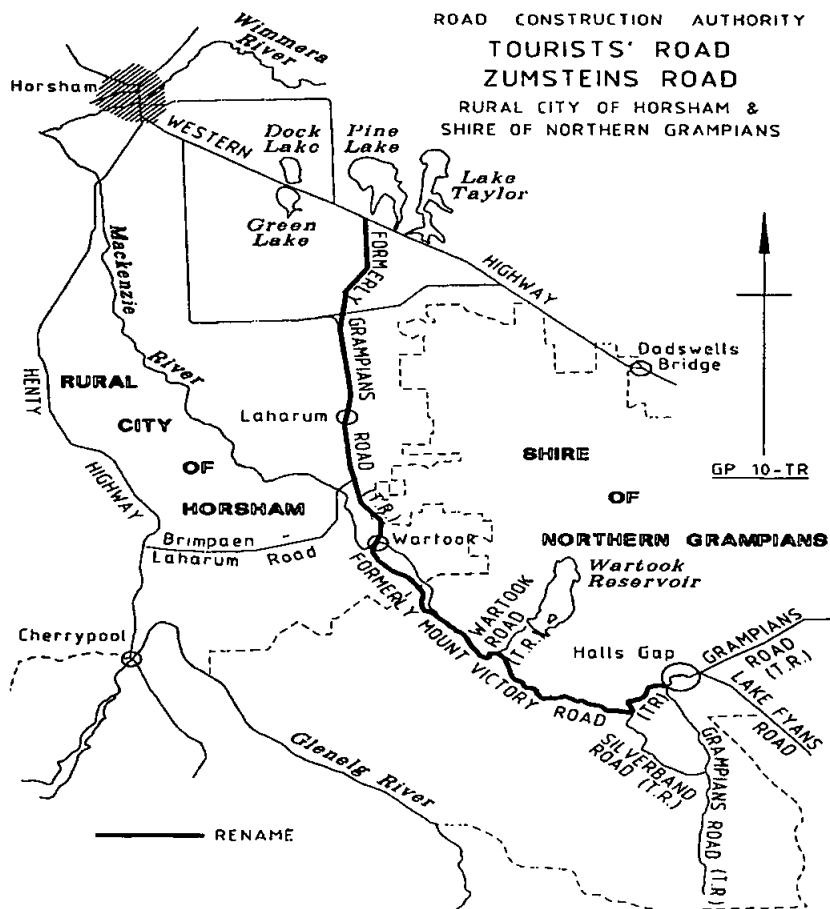

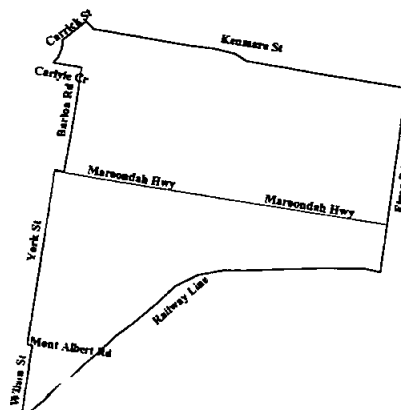
