I, PATRICK JOHN McNAMARA, as Minister administering the Water Act 1989, make the following Order:

CHANGE TO THE MEMBERSHIP OF THE GOULBURN VALLEY REGION WATER AUTHORITY ORDER 1997

Citation

1. This Order is called the Change to the Membership of the Goulburn Valley Region Water Authority Order 1997.

Enabling Powers

2. This Order is made under the powers conferred by Division 2 Part 6 of the Water Act 1989 and all other available powers.

Date of Effect

3. This Order takes effect on 1 November 1997.

Definitions

- 4. In this Order:
- "Act" means the Water Act 1989.

"The Authority" means the Goulburn Valley Region Water Authority.

"The Constitution Order" means the Constitution of the Goulburn Valley Region Water Authority Order 1994 published in the Victoria Government Gazette p. 484 G8 of 24 February 1994.

Change to the Membership

5. On and from the date on which this Order takes effect:

Notwithstanding anything to the contrary in the Constitution Order, the membership of the Authority is ten members appointed by the Minister in writing.

Pre-requisites for Making this Order

6. This is an Order referred to in Section 99(8) of the Act.
