## Office of the Regulator-General Act 1994 NOTICE OF DETERMINATION

On 9 April 1997, the Office of the Regulator-General made a determination under section 26 of the Office of the Regulator-General Act 1994.

The determination varied the Electricity Industry Supply and Sale Code published in Gazette No. S127 on 8 November 1996 by -

- deleting clause 4.2.1 and Appendix No. 1;
  and
- inserting a new clause 4.2.1 and a new Appendix No.1.

The variation to the Supply and Sale Code will make clear that, where the Code states that a supplier may be required to compensate a customer for damage to the customer or the customer's property caused by the fault of the supplier, the requirement does not limit any rights that a customer may have under the Trades Practices Act 1974.

The variation does not affect rights accrued or obligations incurred under the Electricity Industry Supply and Sale Code prior to the determination being made.

The determination takes effect on and from the date that a copy of this notice is published in the Government Gazette.
