THE HONOURABLE SIR JAMES AUGUSTINE GOBBO AC
to be Governor of the State of Victoria in the Commonwealth of Australia

ELIZABETH THE SECOND, by the Grace of God Queen of Australia and Her other Realms and Territories, Head of the Commonwealth: To the Honourable Sir James Augustine Gobbo AC Greeting:

We hereby appoint you James Augustine Gobbo, under section 6(2) of the **Constitution Act 1975** of the State of Victoria to be, during Our Pleasure, Our Governor of Our State of Victoria, in the Commonwealth of Australia.

AND WE hereby authorise, empower and command you to perform the powers and functions of the Office of Governor in accordance with the **Constitution Act 1975** of Victoria, the **Constitution Act Amendment Act 1958** of Victoria, the **Australia Acts 1986** of the Commonwealth of Australia and of the United Kingdom, and all other applicable laws.

AND as soon as you have taken the prescribed Oaths and have entered upon the duties of your Office of Governor, this Commission shall supersede our Commission dated 10 April 1992 appointing the Honourable Richard Elgin McGarvie to be Governor of Our State of Victoria.

AND we hereby command all our subjects in Our State of Victoria and all other persons who may lawfully be required to do so to give due respect and obedience to the Governor accordingly.

Her Majesty has been graciously pleased by Commission under Her Royal Sign Manual and the Public Seal of the State of Victoria dated at Her Majesty's Court at St. James's on 18 March 1997, to appoint me, James Augustine Gobbo, to be Governor of the State of Victoria in the Commonwealth of Australia:

I hereby proclaim and declare that I have today taken the prescribed oaths before the Honourable John Harber Phillips, Chief Justice of the Supreme Court of Victoria, and before the Executive Council of the State, at Parliament House, Spring Street, Melbourne, and I have assumed the Office of Governor of the state of Victoria under and by virtue of Her Majesty's Commission.
