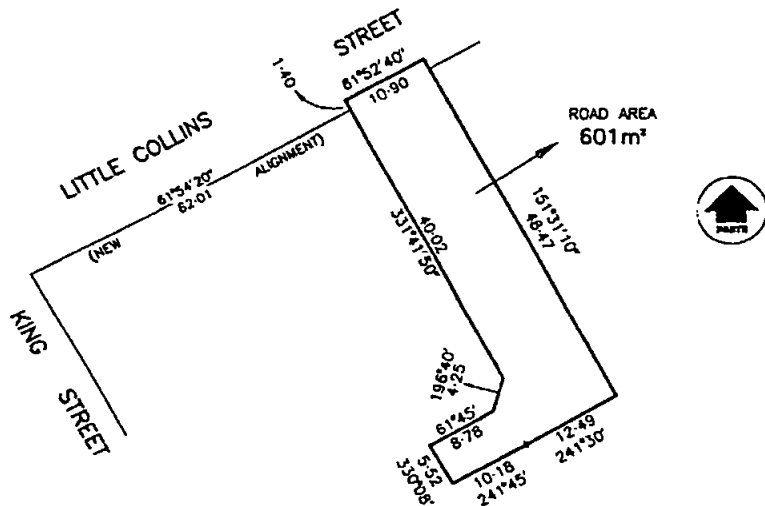

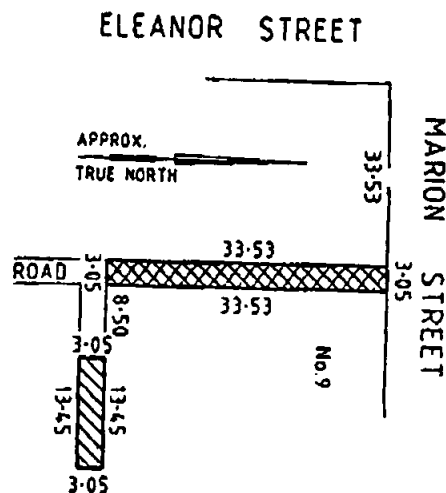

- that there is a definite need for there to be a certain amount of massage clinics available for just women to visit;
- that regular female patients of the applicant have stated that they would not feel comfortable at all knowing that there are men out in the waiting room whilst they are lying on the massage table in their underwear;
- because the applicant's practice is conducted from her home and the nature of her work is sometimes misconstrued by men to be work of a sexual nature there are additional personal and safety considerations that lead the applicant to wish to offer her services to women only.

The Tribunal grants an exemption from the operation of Sections 42, 100 and 195 of the **Equal Opportunity Act 1995**, to enable the

- the program can advocate for young women's right to make decisions about their lives, and is able to model a

mutually respectful relationship for the time it is in contact with the young women;

- all current staff are female; this is frequently a crucial factor in allowing abused young women to feel safe;
- all staff will have direct contact with the young women in question;
- Napier Youth Services provides support services to the young women resident at the two Mission to Streets and Lanes residential units for young women, Napier House and Counterpoint. Both of these residential units have exemptions to employ all-female staff (Nos 23/94 and 3/95).

Only 3 aspects of the Regulations are considered to impose any appreciable burden on any sector of the public. These issues were dealt with separately in the RIS and are as follows—

- (a) require a person selling Schedule 4 reptiles to a wildlife dealer to provide appropriate identification and the dealer to record details of the identification and transaction onto a form;

- (b) require persons under the age of 18 years to demonstrate their capability to handle venomous snakes before being permitted to possess them;

- (c) require licensed trappers to place the mark provided by the Secretary on trapped birds at the point of capture.

The RIS examined one alternative to the proposed Regulations in respect of each of the above-mentioned provisions and concluded that the proposed Regulations are the most effective means of meeting the objective in each case.
